PREFACE

THIS IS TO BE CONSIDERED A DOCUMENTARY IN AN EFFORT TO LET INTERESTED PERSONS KNOW JUST HOW MEAGER THE BEGINNING OF RURAL FIRE PROTECTION IN COLLETON COUNTY REALLY WAS.

IT HAS BEEN COMPLIED FOR THIS PURPOSE ONLY AND NOT FOR FAME OR PERSONAL GAIN AND CAN BE COPIED OR USED IN ANY WAY DESIRED.

THERE IS NO CHRONOLOGICAL ORDER INTENDED AS RECORDS FROM SOME FORTY YEARS AGO WERE HARD TO LOCATE AND EVENTS WERE RECORDED AS THEY CAME TO MIND OR INFORMATION WAS GIVEN TO ME.

IN 1994 COLLETON COUNTY TOOK OVER THE RURAL FIRE DE-PARTMENTS AND LATER THE EMS BECAME A PART OF WHAT IS NOW COLLETON COUNTY FIRE-RESCUE.

COLLETON COUNTY FIRE-RESCUE NOW HAS AN ISO RATING OF CLASS 4, 32 FIRE STATIONS, 250 VOLUNTEERS, 70 CROSS-TRAINED CAREER PERSONNEL, 105 VEHICLES AND PROVIDES FIRE, RESCUE AND EMS SERVICES FOR SOME 1054 SQUARE MILES IN COLLETON COUNTY.

ONE OF MY FEW REGRETS IS THAT SO MANY THAT WORKED SO HARD TO PROVIDE A BARE MINIMUM OF FIRE PROTECTION FOR COLLETON COUNTY ARE NOW DECEASED AND ARE NOT HERE TO SEE WHAT MATERIALIZED FROM THEIR EFFORTS MANY YEARS AGO.



COLLETON RURAL FIRE DEPARTMENT COLLETON VOLUNTEER FIREMEN'S ASSOCIATION, INC.

THE RESIDENTS OF RURAL COLLETON COUNTY HAD NO FIRE PROTECTION PRIOR TO OUR ORGANIZATION EXCEPT WHEN CALLS FOR ASSISTANCE WOULD BE ANSWERED BY A NEIGHBORING FIRE DEPARTMENT. THE ONLY ORGANIZED FIRE DEPARTMENTS IN COLLETON COUNTY WERE THE WALTERBORO FIRE DEPARTMENT AND THE TOWN OF WILLIAMS AND THE WILLIAMS FIRE DEPARTMENT COULD RESPOND ONLY WITHIN THE TOWN LIMITS.

THE CITY OF WALTERBORO WAS PROVIDING A BARE MINIMUM OF FIRE PROTECTION OUTSIDE OF THE CITY UNTIL OCTOBER 1, 1966 WHEN CITY COUNCIL LIMITED FIRE DEPARTMENT RESPONSE TO THE CITY LIMITS. UNTIL THIS TIME THE FIRE DEPARTMENT COULD ANSWER CALLS OUTSIDE THE CITY LIMITS OF WALTERBORO, IF PERMISSION WAS GIVEN BY THE "MAYOR, THE MAYOR PRO-TEMPORE, THE RANKING MEMBER OF THE FIRE DEPARTMENT COMMITTEE, THE FIRE CHIEF, OR THE ASSISTANT FIRE CHIEF; AND, THAT REQUESTS FOR SUCH ASSISTANCE WILL BE MADE OF THE ABOVE OFFICIALS IN THE ORDER NAMED" (SEE MINUTES OF CITY COUNCIL DATED APRIL 15, 1958). NEEDLESS TO SAY, MUCH VALUABLE PROPERTY WAS LOST TO FIRE BECAUSE OF THE TIME WASTED TO CONTACT THE PROPER OFFICIALS FOR AUTHORITY TO RESPOND TO OUT-OF-TOWN CALLS.

ALTHOUGH I PERSONALLY REGRETED THE DECISION TO LIMIT THE RESPONSE OF THE WALTER-BORO FIRE DEPARTMENT TO THE CITY LIMITS, I COULD WELL UNDERSTAND THE REASONING BECAUSE IT HAD BECOME A GREAT LIABILITY FOR THE CITY, WITH MANPOWER AS WELL AS FINANCIALLY.

MINUTES OF COUNCIL

April 15, 1958

Councilman Dean made a report for the Fire Department Committee regarding need for some regulations governing requests for assistance in "out of Town" fire calls, submitting the following recommendations:

- That calls for fire assistance outside the corporate limits of the Town of Walterboro will be answered only upon the order of the Mayor, the Mayor Pro-Tempore, the ranking member of the Fire Department Committee, the Fire Chief or the Assistant Fire chief; and, that requests for such assistance will be made of the above officials in the order named;
- 2. That a radio be installed in the newest fire truck, thereby giving the department two (2) radio equipped trucks at all times;
- 3. That when answering "out of town" calls for fire assistance one (1) radio equipped truck, the Fireman-Caretaker and two (2) volunteer firemen will remain on call at the fire station until all fire fighting equipment has been returned to the station;
- 4. That the rate of pay for volunteer firemen shall be as follows:

WFD PROCEDURE FOR RURAL CALLS BEFORE 10/1/66

ON JUNE 20, 1967 THE SOUTHEASTERN UNDERWRITERS ASSOCIATION (THE ORGANIZATION THAT HELPED REGULATE INSURANCE PREMIUMS) RECOMMENDED TO THE CITY THAT A NEW PUMPER BE PURCHASED. EARLY IN 1968 THE CITY AGREED TO PURCHASE THIS NEW PUMPER AND THE FIRE CHIEF (THEO SYFRETT, MY FATHER) AND I WERE GIVEN THE TASK OF PROVIDING THE SPECIFICATIONS. IN DISCUSSING THE MANY OPTIONS AVAILABLE WITH FIRE TRUCK MANUFACTURERS, I WAS INFORMED THAT CITY AND COUNTY OFFICIALS HAD MET TO DISCUSS THE POSSIBILITY OF RURAL FIRE PROTECTION FOR COLLETON COUNTY. THIS MEETING WAS HELD FEBRUARY 29, 1968 AT THE SOUTHLAND RESTAURANT WITH THE STATE FIRE MARSHALL, JESSIE C. JOHNSON AND RONALD C. SELF OF THE SOUTHEASTERN UNDERWRITERS (ISO) AS GUEST SPEAKERS.

EVEN THOUGH NO ONE FROM THE WALTERBORO FIRE DEPARTMENT HAD BEEN INVITED TO THIS MEETING, I WANTED TO BE INVOLVED IN HELPING TO ORGANIZE A COUNTY FIRE DEPARTMENT. ALTHOUGH I HAD BEEN A LIFETIME RESIDENT OF COLLETON COUNTY I DID NOT REALIZE JUST HOW LARGE OUR COUNTY WAS, ESPECIALLY WHEN IT CAME TO PROVIDING COUNTY-WIDE FIRE PROTECTION.

IN NOVEMBER OF 1967 THE SEVEN-UP BOTTLING COMPANY ON HWY 15N WHERE PALMETTO MEDICAL SERVICES IS NOW LOCATED, LOST A LARGE STORAGE BUILDING AND COOLER VENDER ROOM (SEE PRESS & STANDARD ARTICLE DATED 11/07/67) TO FIRE WHEN THE WALTER-BORO FIRE DEPARTMENT WAS PROHIBITED FROM SENDING HELP. NEEDLESS TO SAY THERE WERE MANY SPECTATORS AT THIS DAY-TIME FIRE, AND BECAUSE MANY THOUSANDS OF DOLLARS WERE LOST TO FIRE, THIS INCIDENT LET MANY RESDENTS OF THE RURAL AREAS REALIZE THE NEED FOR FIRE PROTECTION.

ON APRIL 3, 1968, THE CARTER'S FORD CHURCH WAS LOST TO FIRE BECAUSE THERE WAS NO FIREFIGHTING FACILITIES AVAILABLE WITHIN A REASONABLE DISTANCE. THE CITY WAS AGAIN PROHIBITIED FROM SENDING MEN AND EQUIPMENT. SOON AFTER THIS FIRE, THE WALTERBORO CITY COUNCIL AUTHORIZED RESPONSE TO ANY CHURCH OR SCHOOL COUNTY-WIDE. THIS RE-EMPHASIZED THE FACT THAT RURAL FIRE PROTECTION WAS NEEDED IN COLLETON COUNTY.

I HAVE ALWAYS SAID THAT THE FIRE AT CARTER'S FORD CHURCH LED TO THE ORGANIZATION
OF RURAL FIRE PROTECTION IN COLLETON COUNTY AS MANY CHRUCH MEMBERS AND
RESIDENTS OF COLLETON COUNTY FELT THAT WITH A BARE MINIMUM OF FIRE FIGHTING
EQUIPMENT MUCH PROPERTY COULD HAVE BEEN SAVED.

IN MARCH OF 1968 I CONTACTED MR. J. P. HARRELSON, OUR COUNTY SENATOR AT THAT TIME, AND INFORMED HIM THAT I HAD HEARD THERE WAS INTEREST IN PROVIDING RURAL FIRE PROTECTION AND THAT I WOULD LIKE TO BE A PART OF ITS ORGANIZATION. I RECEIVED A REPLY FROM MR. HARRELSON (SEE HIS LETTER TO ME DATED MARCH 15, 1968) STATING THAT THEY HAD BEEN INVESTIGATING THE POSSIBILITY OF RURAL FIRE PROTECTION AND THAT THEY INTENDED TO APPOINT A STUDY COMMITTEE.

THIS COMMITTEE WAS APPOINTED AND NAMED THE COLLETON COUNTY RURAL FIRE PROTECTION STUDY COMMITTEE. THE FIRST MEETING OF THIS COMMITTEE WAS HELD IN THE OFFICE OF SENATOR J. P. HARRELSON ON DECEMBER 16, 1968. MR. F. B. THOMAS OF COTTAGEVILLE WAS ELECTED CHAIRMAN, MR. RYAN WHITE, VICE-CHAIRMAN, AND MR. MURRAY WOOD, SECRETARY. OTHER MEMBERS WERE MR. C. P. FISHBURNE, MR. GILBERT BROWN, MR. LAURIE SMOAK, AND MR. TOMMY GODWIN.

ON JANUARY 16, 1969 THIS COMMITTEE HELD ITS FIRST OFFICIAL MEETING IN THE AGRICULTRUAL BUILDING WITH MR. RONALD SELF OF THE SOUTHEASTEN UNDERWRITERS IN ATTENDANCE. MR. SELF MADE AVAILABLE THE INFORMATION HIS OFFICE HAD WORKED UP FOR COLLETON COUNTY AND SEVERAL SUCCESSFUL FIRE PROTECTION SYSTEMS IN THE STATE. AT THIS MEETING IT BECAME EVIDENT THAT IMMEDIATE COUNTY-WIDE FIRE PROTECTION WOULD NOT BE POSSIBLE. MR. SELF INFORMED US THAT IT WOULD TAKE A MINIMUM OF TEN DISTRICTS (TEN FIRE DEPARTMENTS) TO SERVE THE ENTIRE COUNTY AND EVEN THEN THERE WOULD BE A FEW PLACES THAT WOULD NOT HAVE FIRE PROTECTION ALTHOUGH THEY WOULD RECEIVE A LOWER INSURANCE RATING IF ALL THE COUNTY DEPARTMENTS WERE RATED. THESE WERE: WALTERBORO, JACKSONBORO, LODGE, SMOAKS, CANADYS, RUFFIN, HENDERSONVILLE, COTTAGEVILLE, GREENPOND, AND ISLANDTON. TO ORGANIZE AND EQUIP

SENATOR HARRELSON'S REPLY TO MY REQUEST 3/15/68

THIS MANY FIRE DEPARTMENTS WITH TAX MONIES WOULD REQUIRE AN INCREASE IN COUNTY
TAXES AND NATURALLY THE POLITICIANS WOULD NOT EVEN CONSIDER THAT.

IN JULY OF 1969 THIS COMMITTEE RECOMMENDED A VOLUNTEER MEMBERSHIP PLAN BE USED TO FINANCE RURAL FIRE PROTECTION. THIS WOULD MEAN THAT ONLY PAID MEMBERS WOULD HAVE FIRE PROTECTION. IT IS NO WAY I CAN DESCRIBE OUR FEELINGS WHEN WE RECEIVED A CALL AND WERE UNABLE TO ASSIST BECAUSE WE HAD NOT RECEIVED A MEMBERSHIP (THE FIRST MEMBERSHIP WAS TEN DOLLARS PER YEAR FOR A RESIDENCE). THANKS TO OUR MANY SUPPORTERS THIS PLAN WORKED FOR SEVERAL YEARS, BUT NOT WITHOUT PROBLEMS (SOME OF THESE WILL BE MENTIONED LATER).

IN SEPTEMBER OF 1968 I RECEIVED WORD THAT THE COUNTY HAD SECURED AN OLD SCHOOL BUS TANK TRUCK TO BE USED TO PROVIDE FIRE PROTECTION AT THE AIRPORT. AS THIS TRUCK HAD BEEN AT THE AIRPORT FOR MANY MONTHS AND HAD NOT BEEN UTILIZED, I REQUESTED THIS UNIT TO BE TURNED OVER TO ME IN AN EFFORT TO PROVIDE SOME FIRE PROTECTION IN THE RURAL AREAS. THROUGH THE EFFORTS OF THE COUNTY AIRPORT COMMISSION, SENATOR J. P. HARRELSON, AND ROGER ODUM OF THE COUNTY DEVELOPMENT BOARD, I RECEIVED PERMISSION TO USE THIS UNIT IN OCTOBER OF 1968.

ON OCTOBER 11, 1968, NEIL CROSBY AND I SECURED THIS OLD TANK TRUCK FROM THE AIRPORT. WE HAD ABSOLUTELY NO IDEA WHAT TO DO NEXT AS WE WERE ALREADY TWO DOLLARS IN DEBT. WE HAD PUT TWO DOLLARS WORTH OF GAS (5.9 GALLONS) IN THIS TRUCK AND CHARGED IT TO MY CREDIT CARD.

IT WAS VERY ENCOURAGING WHEN WE ASKED FOR HELP IN GETTING THIS OLD TRUCK READY TO FIGHT FIRE. THIS TRUCK WAS YELLOW AND NOBODY WANTED A YELLOW FIRE TRUCK. THEREFORE, OUR FIRST PRIORITY WAS TO PAINT IT RED. THIS UNIT WAS OLD BUT IN REAL GOOD MECHANICAL SHAPE AND WE SPENT THE NEXT COUPLE OF WEEKS GETTING IT READY FOR PAINT. MR. PETE SMOAK, AN EMPLOYEE OF WALTERBORO MOTOR SALES, SPRAYED IT FOR US USING THE PAINT BOOTH AT WALTERBORO MOTOR SALES AND WALTERBORO AUTO

The Colleton County Rural Fire Protection Study Committee held its first meeting in the office of Senator J. P. Harrelson, December 16, 1968 for the purpose of organizing and hearing from the County Delegation our duties and responsibilities. The committee was informed that its responsibilities were to make a study on the feasibility of a rural fire protection plan best suited for the county and present a report to the Delegation as soon as the study was completed. F. B. Thomas was elected Chairman, Ryan Mhite, Vice Chairman, Murray Wood, Secretary. Other members of the committee were C. P. Fishburne, Gilbert Brown, Laurie Smoak, and Tommy Godwin.

The committee held its first official meeting January 16, 1969 in the County Agricultural Bldg., with Mr. Ronald Self from the State Fire Marshall's office in Columbia, in attendance. Mr. Self made available to the committee the information that his office had worked up for Colleton County. He also pointed out the successful fire protection systems presently operating in the state. It was decided at this meeting that a committee would visit several of these counties for the purpose of studying their organization and operational procedures.

For the next several weeks, the following counties were visited by a member or members of the Colleton County Rural Fire Study Committee: Newberry, Oconee, York, Sumater, and Marion.

We found these systems operating as a result of our study in the counties visited: (1) <u>County-Hide coverage</u> - with county financing entire set up by taxation. (2) <u>County-Hide fire districts</u> - with county paying part and each individual district paying part. County's part financed by taxation and community's part from individual contributions from citizens in the fire district. (3) <u>Volunteer fire departments - County-Hide</u> - organized on a membership basis with a working relationship with the municipalities in the county. This plan is financed by membership and donations. It is operated by a board of directors elected by the membership and the board acts as the rural fire protection committee for the

Several meetings were held with the study committee to discuss the various plans being used by other counties to decide in our opinion which was the best, if any, for Colleton County. No other plan was introduced other than the three previously mentioned.

Plan 1 and 2 probably could be grouped together since the primary source of revenue would require a vote from the people either county-wide or each fire district and a bond issue to be repaid by taxation. If it were financed by county, it would cost approximately \$350,000 for an initial investment to cover 10 fire districts with maintenance cost of approximately \$10,000 per year. If county was to adopt fire district plan, the cost would be approximately \$25,000 per district to the county and \$10,000 to the individual fire department. The maintenance cost would remain about the same.

Because of the tremendous cost of Plan No. 1 and 2, the committee felt that the people of the county would not approve a bond issue for the county in a referrendum, and for this reason, Plan No. 1 and 2 were unfavorable in our recommendation to the Delegation.

Plan No. 3 is being recommended to the Delegation from the Rural fire Protection Study Committee as feasible plan to follow in Colleton County. This would not require a vote from the people, a bond issue, or additional property taxation on the county. Several agricultural organizations, along with a number of our rural citizens were consulted in regard to their opinion about the membership fire department, versus the taxation plan. All who expressed an opinion were in favor of the membership fire department.

The committee, therefore, further recommends that a county-wide non-profit organization be established for the purpose of rural fire protection and that Colleton County make a loan to this organization in the amount of \$ _____ for the purchase of one fire truck with appropriate equipment. This loan to be repaid from membership dues and



contributions to the association and satisfactory arrangements for repayment of loan to be worked out between Colleton County and the non-profit association.



CRFD'S FIRST BILL FOR ELECTRICITY

PARTS (NAPA) DONATED TWO GALLONS OF RED PAINT. MR. ALBERT LUCAS WITH THE CITY WATER DEPARTMENT WAS THEN CONTACTED CONCERNING A PUMP. HE TOLD ME WITHOUT HESITATION THAT HE HAD A PUMP POWERED BY A 10 HP ELECTRIC MOTOR THAT WE COULD POSSIBLY USE WITH A POWER TAKE-OFF. OF COURSE WE STILL HAD NO MONEY AND NO POWER TAKE-OFF. MR. NOLAN BAILEY, SR. CALLED ME AND TOLD ME THAT HE HAD AN OLD CITY GARBAGE TRUCK IN HIS JUNK YARD THAT HAD A POWER TAKE-OFF AND THAT WE WERE WELCOME TO IT. NOW WE HAD TO GET ALL OF THIS INSTALLED TO SEE IF ANY OF IT WOULD WORK. AGAIN, A FRIEND CAME TO OUR RESCUE, MR. LESLIE MCGRAW, A FORMER EMPLOYEE OF WALTERBORO MOTOR SALES, AND I WORKED FOR MANY HOURS INSTALLING THIS PUMP WITH PULLEYS AND A CHAIN DRIVE. WE NEEDED SOME FITTINGS MADE AND SOME WELDING DONE AND WE STILL HAD NO MONEY TO PAY FOR ANYTHING. THIS IS WHEN MR. HARRY FRALIN (FRALIN'S WELDING SERVICE) AND HIS SON STEVE GOT INVOLVED. HIS SHOP WAS LOCATED ON SOUTH JEFFERIES WHERE GLASSPRO IS NOW. MR. FRALIN SPENT MANY HOURS HELPING US GET THIS TRUCK WHERE IT WOULD PUMP WATER AND BE READY TO RESPOND TO A FIRE CALL. THIS TRUCK WAS ACTUALLY HOUSED AT THIS LOCATION FOR SEVERAL MONTHS AND WE RESPONDED TO OUR FIRST CALL FROM THERE. WE NOW FINALLY HAD A TRUCK THAT WOULD PUMP WATER, NOT MUCH WATER, BUT IT WAS RED AND WE CALLED IT A "FIRE TRUCK".

THE FIRST CALL ANSWERED WAS TO THE RESIDENCE OF HENRY CROSBY, NEAR ASHEPOO, ON JANUARY 17, 1969. VERY LITTLE DAMAGE WAS DONE AND MR. CROSBY GAVE US A \$20.00 DONATION (OUR FIRST DONATION). TWENTY DOLLARS DOES NOT SEEM MUCH TODAY, BUT IN 1969 IT WOULD BUY A LOT OF GASOLINE.

WE HAD BEEN PROMISED MANY DONATIONS BUT MANY OF THE DONORS DESIRED THEIR DONATIONS TO BE TAX DEDUCTIBLE. WE WERE ADVISED THAT THE ONLY WAY THIS COULD BE WAS TO FORM AN ORGANIZATION FOR THIS PURPOSE. THE COLLETON VOLUNTEER FIREMEN'S ASSOCIATION WAS THEN CHARTERED AS AN ELEEMOSYNARY CORPORATION. ASHTON SYFRETT WAS TO BE PRESIDENT, ALFRED ANDREWS, VICE-PRESIDENT, WILLIAM V. CAMPBELL, TREASURER. AND ROBERT P. MCLAINE, SECRETARY. WHEN THE CHARTER WAS RECEIVED.

MCLAINE, TRAINING OFFICER, AND WILLIAM CAMPBELL, SECRETARY-TREASURRER. THE OTHER CHARTER MEMBERS WERE: NEIL CROSBY, TROY HUDSON, TOMMY FULTON, ERROL STYNCHCOMB, STEVE FRALIN, JAMES WARREN, JIMMY CROSBY, MICHAEL BRELAND, MOYE PADGETT. JR., HARRIS CARTER, AND HERMAN L. (JACK) MOCK.

- 3. PERMIT THE MEMBERS FROM THE RURAL FIRE DEPARTMENT TO TRAIN WITH THE CITY DEPARTMENT UNTIL A SEPARATE PROGRAM CAN BE ESTABLISHED. THIS WILL BE SUBJECT TO THE APPROVAL OF THE CITY FIRE CHIEF AND THE CITY FIRE PERSONNEL.

THESE REQUESTS WERE GRANTED BY AND THE CITY HOUSED THE CONVERTED TANK TRUCK FOR MANY MONTHS AND RECEIVED AND DISPATCHED CALLS FOR MANY YEARS.

AS TIME WENT ON AND THE VOLUME OF CALLS INCREASED, WE REALIZED THE IMPORTANCE OF TRAINING. WHEN MR. ROBERT P. MCLAINE, JR. BECAME OUR FIRST TRAINING OFFICER HE WAS THE ASSISTANT CHIEF AT THE MARINE CORPS AIR STATION AND HE WAS NOT ONLY ABLE TO ASSIST WITH TRAINING BUT WITH THE GENERAL OPERATION OF THE FIRE DEPARTMENT AS WELL AS FIREFIGHTING ITSELF. MR. MCLAINE DID A LOT OF WORK BEHIND THE SCENES THAT NOBODY APPRECIATED MORE THAN ME AND I ALWAYS REGRETTED IT WHEN HE RESIGNED FROM THE DEPARTMENT.


THE FIRST TRAINING CLASSES IN COLLETON COUNTY THAT WERE SPONSORED BY THE SOUTH CAROLINA STATE FIREMEN'S ASSOCIATION WERE IN COOPERATION WITH THE STATE COMMITTEE FOR TECHNICAL EDUCATION. THE FIRST CLASS WAS COMPLETED APRIL 1, 1972 AND CONSISTED OF SOME TEN MEN FROM COLLETON COUNTY. THEY WERE AS FOLLOWS: HERMAN L. (JACK) MOCK, STEVE FRALIN, W. P. LLOYD, JACK BEVERLY, K. L. BENTON, LANDIS CARTER, J. C. SINEATH, JR., CLYDE FENDER, ALFRED W. (ANDY) ANDREWS, AND MYSELF. THIS WAS THE FIRST "OFFICIAL" TRAINING CLASS FOR COLLETON COUNTY WHERE THE S. C. STATE FIREMEN'S ASSOCIATION WAS CONCERNED.

THE COUNTY HAD AGREED TO FURNISH THE LIABILITY INSURANCE ON THIS TRUCK SO WE FELT WE AT LEAST HAD A START WHERE RURAL FIRE PROTECTION WAS CONCERNED. BUT, ON MARCH 20, 1969, MRS. MYRTIS FRIPP, THE COUNTY SUPERVISOR AT THAT TIME, CALLED ME INTO HER OFFICE AT THE COURTHOUSE AND INFORMED ME THAT THE COUNTY WOULD NO LONGER INSURE THIS TRUCK AND WE HAD A CHOICE TO "OWN IT OR PARK IT". NEEDLESS TO SAY, I REQUESTED THE TITLE, WHICH I STILL HAVE.

AS WE HAD NO FUNDS TO PURCHASE INSURANCE, THIS TRUCK WAS PARKED MUCH TO THE DISMAY OF THE VOLUNTEER FIREMEN. HOWEVER, SOME SIX DAYS LATER ON MARCH 26, 1969 (5:10 PM) WE RECEIVED A CALL FROM EDISTO LUMBER ON THE BELLS HIGHWAY FOR A WOODS

WILLIAM (BILL) CAMPBELL AT FIRST BAPTIST CHURCH WHERE HE WAS MINISTER OF MUSIC AND ASKED HIS ADVICE. WITHOUT HESITATION HE SAID HE WOULD DRIVE THE TRUCK AND FOR ME TO MEET HIM AT THE SCENE. WE DID A GOOD JOB FOR EDISTO LUMBER COMPANY THAT DAY AND THAT HELPED OUR MORALE VERY MUCH.

THE PRESS & STANDARD HAD AGREED TO AN ARTICLE ASKING FOR HELP FOR OUR ORGANIZATION AND IT WAS DISTRIBUTED THE SAME DAY OF THE FIRE. THE NEXT MORNING MR. BILL CAMPBELL CALLED ME TO LET ME KNOW THAT MR. MERIC WILLIAMS, THE OWNER OF EDISTO LUMBER COMPANY, HAD PAID THE INSURANCE FOR A YEAR STATING THAT "THERE WAS NO WAY THE LACK OF INSURANCE WAS GOING TO STAND IN OUR WAY". WE ALSO RECEIVED A DONATION FROM MR. R. C. THOMPSON AT T & M HANDLE COMPANY IN THE AMOUNT OF \$25.00. THIS LET US KNOW WE HAD AT LEAST TWO SUPPORTERS. MR. R. C. THOMPSON, JR. WOULD LATER BECOME AN ACTIVE FIREMAN AND FOR MANY YEARS, HE SPENT MANY HOURS OF HIS TIME WORKING WITH THE RURAL FIRE DEPARTMENTS IN THE COUNTY.

FOR MANY YEARS THE DUST HOUSE AT EDISTO LUMBER COMPANY WOULD REQUIRE OUR RESPONSE ON A REGULAR BASIS. WE BECAME QUITE FAMILIAR WITH THIS LOCATION AND EXTINGUISHING THESE FIRES BECAME QUITE ROUTINE. WE WOULD ALWAYS SEEM TO HAVE A FIRE CALL THERE (AND RECEIVE A DONATION) JUST WHEN IT WAS NEEDED THE MOST.

WE THEN PURCHASED A LADDER FROM CORBETT BUILDING SUPPLY ON APRIL 10, 1969 FOR \$26.86. THIS WAS OUR FIRST EQUIPMENT PURCHASE.

AT THIS TIME INSURANCE COMPANIES CONSIDERED FIRE TRUCKS A BAD RISK AND IT WAS VERY HARD TO FIND A COMPANY THAT WOULD INSURE US. FINALLY ON APRIL 9, 1969, THE FIREMAN'S FUND INSURANCE COMPANY AGREED TO INSURE US THANKS TO MR. EDWIN F. (EDDIE) SAUNDERS OF THE SAUNDERS AGENCY HERE IN WALTERBORO. I WAS LISTED AS THE PRINCIPAL DRIVER FOR THIS VEHICLE AND YOU WILL NOTE THE EXTRA CHARGE OF \$26.00 BECAUSE I HAD RECEIVED A SPEEDING TICKET ON DECEMBER 6, 1966 (THIS WAS IN RAVENEL).

IN SEPTEMBER OF 1969, THANKS TO THE SUPPORT OF DEPARTMENT OF EDUCATION IN COLUM-IBIA, WE WERE ABLE TO SECURE ANOTHER SCHOOL BUS TANK TRUCK. THIS WAS THE TRUCK LATER DESTROYED BY FIRE IN THE HENDERSONVILLE DISTRICT.

AS SOON AS THE RURAL FIRE STUDY COMMITTE MADE ITS RECOMMENDATION OF FINANCING RURAL FIRE PROTECTION BY MEMBERSHIP WE STARTED OUR DRIVE TO PURCHASE A PUMPER THE FIRST MEMBERSHIP WAS PAID TO FIREMAN STEVE FRALIN BY MR. JACOB PELLUM OF PELLUM'S EXXON ON SOUTH JEFFERIES BLVD.







A Conversation With Legendary Bill Darley

MELROSE PARK, Ill. — Bill Darley walks into the room and begins to greet people, even strangers, with a warm hand shake and a smile that makes you feel like you've known him for years.

"Welcome to Darley," he said, gripping a visitor's hand, welcoming him into the vast enterprise where he has been the benevolent ruler for 46 years.

Bill Darley has been in the fire truck and fire pump manufacturing for most of those as president of the W.S. Darley & Co., a municipal equipment business his father founded 90 years ago.

An icon in the fire apparatus business just about everybody who has anything to do with fire equipment knows Bill Darley and those who don't quickly become at ease with the man who likes to tell humorous stories and reminisce about days gone by.

The business card he hands out has a four-color picture of himself next to a fire truck parked outside the plant just so people won't forget who he is and what he does.

But it's not necessary; nobody forgets Bill Darley.

Even though he'll be stepping down as president on his 70th birthday on July 17, he still speaks enthusiastically about



HARDEE'S IS NOW) AND TOOK GREAT PLEASURE IN BURNING THE MORTGAGE.

WHEN WE SIGNED THE CONTRACT FOR THE PURCHASE OF OUR NEW PUMPER WE FELT VERY THANKFUL AS WE NOW HAD A PLACE TO HOUSE OUR EQUIPMENT AND THE CITY WOULD BENEFIT AS IT WOULD BE AVAILABLE FOR CITY FIRES. WE WERE SIMPLY GOING TO HOUSE THE OLD TANK TRUCK AT A LOCAL GARAGE AND HOUSE THE NEW PUMPER AT THE CITY FIRE DEPARTMENT. HOWEVER, SOME THINGS ARE NOT MEANT TO BE, AS UPON OUR RETURN TO WALTER-OCTOBER 26, 1969, WITH OUR NEW PUMPER WE FOUND THAT IT WAS TOO LARGE FOR THE BAY AT THE CITY. WE THEN HAD OUR FIRST MAJOR OBSTACLE. WE HAD THIS BRAND NEW PUMPER WITH NO WAY TO KEEP IT OUT OF THE WEATHER.

MR. GLEN STRICKLAND AND MR. RAYMOND GROOMS, THE OWNERS OF THE STRICKLAND DIXIE CLEANERS ON HAMPTON STREET HAD PURCHASED A BUILDING TO THE REAR OF THE CLEANERS FOR FUTURE EXPANSION. THIS BUILDING HAD HOUSED THE RESCUE SQUAD TRUCK FOR MANY MONTHS AND THE RESCUE SQUAD HAD MOVED ONLY A FEW DAYS BEFORE.

ALFRED (ANDY) ANDREWS AND I WENT TO MR. STRICKLAND'S HOME AND TOLD HIM OUR PROBLEM. EVEN THOUGH IT HAS BEEN OVER THIRTY YEARS AGO, I CAN REMEMBER HOW MR. STRICKLAND, WITHOUT A MOMENTS HESITATION, REACHED INTO HIS POCKET AND GAVE US THE KEY. MR. STRICKLAND AND MR. GROOMS WERE USING THIS BUILDING FOR STORAGE AND AFTER A FEW WEEKS WE ASKED THEM IF WE COULD MOVE THINGS AROUND AND MAKE ROOM FOR OUR OTHER TRUCK (THE OLD CONVERTED SCHOOL BUS TANK TRUCK). PERMISSION WAS GRANTED AND WE MOVED IT FROM THE CITY.

OVER THE NEXT SEVERAL MONTHS WE ANSWERED MANY CALLS AND OUR ORGANIZATION

GREW AS MORE AND MORE RESIDENTS AND PROPERTY OWNERS BECAME AWARE OF OUR

EXISTENCE. MR. JOHNNY RHODES (RHODES OIL COMANY) HAD CONNECTIONS WITH THE

DEPARTMENT OF EDUCATION IN COLUMBIA AND HAD HEARD OF HOW WE WERE UTILIZING THE

OLD SCHOOL BUS TANK TRUCK TO PROVIDE FIRE PROTECTION IN THE RURAL AREAS OF COLLETON COUNTY. MR. RHODES INFORMED ME THAT HE (RHODES OIL COMPANY) HAD TWO OLD TRUCKS THAT HE WOULD DONATE TO OUR ORGANIZATION AND THAT HE HAD CONTACTED THE DEPARTMENT OF EDUCATION AND THERE WERE GOING TO BE SEVERAL MORE OF THE SCHOOL BUS TANK TRUCKS AVAILABLE TO US IN THE NEAR FUTURE IF WE WOULD USE THEM FOR RURAL FIRE PROTECTION. WE FELT THAT THIS WAS JUST TO GOOD TO BE TRUE AND WE HAD ALREADY BEEN CONTACTED IN REGARD TO ORGANIZING FIRE DEPARTMENTS IN OTHER PARTS OF THE COUNTY. OVER THE NEXT FEW YEARS, SOME TEN UNITS WERE MADE AVAILABLE TO US THROUGH THE EFFORTS OF MR. JOHNNY RHODES, MANY AT NO COST TO THE FIRE DEPARTMENTS.

AS STATED BEFORE WE SECURED ANOTHER SCHOOL BUS TANK TRUCK IN SEPTEMBER

OF 1969. IT WAS AT THAT TIME THAT WE ASKED MR. STRICKLAND AND MR.GROOMS TO MOVE

THEIR BOAT AND GIVE US THE OTHER BAY. THIS WAS ALSO DONE WITHOUT HESITATION AND

WE USED THIS BUILDING RENT FREE FOR SOME TEN YEARS.


MR. OSCAR FISK (SOUTH CAROLINA HIGHWAY DEPARTMENT) WAS A GREAT HELP TO THE RURAL FIRE DEPARTMENTS AND VERY FEW PEOPLE REALIZE THAT. WHEN WE WOULD RECEIVE THE OLD SCHOOL BUS TANK TRUCKS FROM THE DEPARTMENT OF EDUCATION, MOST OF THEM NEEDED SOME REPAIRS BEFORE WE COULD USE THEM FOR FIREFIGHTING PURPOSES. I CONTACTED MR. FISK IN AN EFFORT TO OBTAIN A TIRE FOR ONE OF THESE TANKERS. I KNEW THAT MANY TIMES WHERE DUAL WHEELS WERE CONCERNED, THE SCHD WOULD REPLACE BOTH TIRES EVEN IF ONLY ONE WAS DEFECTIVE. THIS WOULD LEAVE A TIRE THAT WOULD RUN FOR MANY YEARS ON ONE OF OUR TRUCKS. MR. FISK STATED THAT HE HAD TO RETURN ALL TIRES TO COLUMBIA AS THEY HAD TO BE ACCOUNTED FOR. I OFFERED TO GIVE HIM AN OLD TIRE BUT HE SAID THAT THEY HAD TO HAVE THE "SCHD" STAMP. WE NEVER HAD TO WORRY ABOUT TIRES AGAIN AS ALL OF THE OLD SCHOOL BUS TANK TRUCKS HAD TIRES WITH THE "SCHD" STAMP. AS THE SCHD ACQUIRED NEW VEHICLES, MANY OF THE PARTS IN THEIR INVENTORY WOULD NOT FIT THE NEW VEHICLES AND HAD TO BE DISPOSED OF. WHEN HE WAS

ALLOWED, MR. FISK WOULD GIVE US THESE OBSOLETE PARTS AND ANYTHING ELSE HE FELT WOULD BE OF USE TO US. THANKS TO MR. OSCAR FISK THE RURAL FIRE DEPARTMENTS OF COLLETON COUNTY SAVED MANY DOLLARS BY USING ITEMS THAT OTHERWISE WOULD HAVE BEEN DISCARDED.

WE NOW HAD A NEW PUMPER, TWO TANKERS, A FIRE STATION CENTRALLY LOCATED IN OUR DISTRICT AND WE WANTED THE PUBLIC TO KNOW IT. WE RECEIVED WORD THATAN THAT AN OLD DEPUTY SHEFIFF'S CAR (WITH NO ENGINE) WAS TO BE AUCTIONED OFF BY THE COUNTY. WE FELT THAT IF WE COULD SECURE THIS VEHICLE, PAINT IT RED AND HAVE OUR ORGANIZATION. WE THEN CONTACTED MR. HAROLD ROBERTSON (ROBERTSON ELECTIRC) AND ASKED HIM TO USE HIS INFLUENCE WITH SENATOR J. P. HARRELSON TO GET THIS VEHICLE FOR US. THE SAME NIGHT MR. ROBERTSON CONTACTED ME AND INFORMED ME THAT THE COUNTY COULD NOT GIVE US THIS VEHICLE BUT I WOULD BE GIVEN THE TITLE FOR FIFTY DOLLARS. THIS BECAME COLLETON COUNTY'S FIRST FIRE CHIEF'S CAR. SOON AFTER THIS ANOTHER CHIEF'S CAR WAS ACQUIRED FOR THE RUFFIN DISTRICT WHERE MR. JACK BEVERY WAS CHIEF. BOTH OF THESE UNITS DID A GREAT JOB IN PROMOTING OUR ORGANIZATION. THE SECOND CHIEF'S CAR FOR DISTRICT 1 WAS RECEIVED IN 1974 AND THIS UNIT ALSO SERVED US WELL.

AT THIS TIME, FIRE PREVENTION PROGRAMS IN COLLETON COUNTY WERE NOT ORGANIZED.

OF COURSE THERE WERE CHILDREN THAT WOULD VISIT THE WALTERBORO FIRE DEPARTMENT AND MEN FROM OTHER DEPARTMENTS, SUCH AS THE PARRIS ISLAND FIRE DEPARTMENT, WOULD HOLD A FEW CLASSES EACH YEAR BUT THERE WERE JUST SO MANY CHILDREN THAT HAD NO CONTACT WITH FIREMEN OR FIRE DEPARTMENTS. WE MADE IT OUR PERSONAL ENDEAVOR TO MAKE CONTACT WITH JUST AS MANY CHILDREN AS POSSIBLE EVEN THOUGH MOST OF US HAD FULL-TIME JOBS. WE THOUGHT THAT IF WE DID SOMETHING FOR THE CHILDREN, THE CHILDREN WOULD TELL THEIR PARENTS (WHO HAD MONEY FOR MEMBERSHIPS). IT DID NOT TAKE LONG FOR US TO REALIZE THAT THERE WAS A LOT OF INTEREST IN FIRE PREVENTION AND WE BEGAN TO SEE THE RESULTS OF OUR EFFORTS. WE SOON BEGAN

TO LOOK FORWARD TO MEETING WITH THE NEXT GROUP. WE ESPECIALLY ENJOYED GOING TO JOHN C. CALHOUN ACADEMY BECAUSE WE KNEW WE WOULD RECEIVE A CAKE OR PIE FROM MRS. ESTER HIERS AS HER WAY OF EXPRESSING APPRECIATION FOR OUR COMING.

WE KNEW THAT IN ORDER TO PROVIDE ADEQUATE FIRE PROTECTION TO OUR MEMBERS
WE WOULD HAVE TO ACQUIRE MORE EQUIPMENT AND WITH OUR LIMITED FUNDS THIS WAS
GOING TO BE QUITE A PROBLEM. I THEN CONTACTED EVERYONE I KNEW THAT COULD
POSSIBLY HELP US IN SECURING ANY KIND OF FIREFIGHTING EQUIPMENT. THESE CONTACTS PAID OFF, AS I STARTED GETTING CALLS FROM PEOPLE I DIDN'T EVEN KNOW.

ONE OF THE FIRST CALLS CAME FROM MR. F. C. WALKER (I DID KNOW HIM) WHO HAD BEEN A A FIREMAN AT THE WALTERBORO ARMY AIRBASE FIRE DEPARTMENT DURING WORLD WAR II. HE TOLD ME THAT HE HAD A BOX OF NOZZLES AND FITTINGS THAT CAME FROM THE AIRBASE AND MAYBE WE COULD USE THEM. IN THIS BOX WERE TWO 2 1/2 "STRAIGHT STREAM NOZZLES THAT WE NEEDED ON OUR NEW PUMPER. THESE NOZZLES WOULD HAVE BEEN EXPENSIVE EVEN AT 1969 PRICES AND THIS WAS MONEY THAT WE JUST DID NOT HAVE. THESE NOZZLES WERE BRASS AND THE HANDLES WERE DETERIOATED BUT WE SURE WERE PROUD TO GET THEM. WE HAD A FRIEND, MR. JACKIE GALLOWAY, THAT HAD CONNECTIONS WHERE CHROME PLATING WAS DONE AND SOON THESE NOZZLES LOOKED LIKE NEW WITH THE NEW CHROME PLATING AND HANDLES MADE FROM ELECTRICAL CONDUIT AND AUTOMOTIVE HEATER HOSE. WE USED THESE NOZZLES FOR SOME THIRTY YEARS AND AS OF THIS DATE THEY ARE ON DISPLAY AT STATION 19 IN THE INDUSTRIAL AREA.

A PIECE OF EQUIPMENT THAT WE FELT WOULD BE AN ASSET TO OUR ORGANIZATION WAS A PUMP THAT WOULD DRAFT FROM A CREEK OR POND TO REFILL OUR TANKERS, MR. GEORGE ACKERMAN (ACKERMAN WELL COMPANY) HAD OFFERED TO SELL US ONE AT HIS COST OF ABOUT A HUNDRED DOLLARS. THE FIRST WOMEN'S AUXILIARY HAD BEEN ORGANIZED AND THEY TOOK IT AS THEIR FIRST PROJECT TO RAISE ENOUGH MONEY TO MAKE THIS PURCHASE. NEEDLESS TO SAY, THEY ACCOMPLISHED THEIR GOAL BY SELLING CAKES, PIES, ETC., AT OUR FIRST OPEN HOUSE.

WE HELD OUR FIRST OPEN HOUSE JUNE 13, 1970 AND HAD A HUGE TURN-OUT OF INTERESTED PERSONS. WE SOLD MANY MEMBERSHIPS AND RECEIVED SEVERAL DONATIONS. THIS WAS GOOD BECAUSE THEN WE ALL KNEW OUR EFFORTS WERE APPRECIATED.

AT THIS OPEN HOUSE I KNEW WE HAD A FRIEND IN CHIEF J. C. TILLMAN, THE CHIEF OF THE CHARLESTON AIR FORCE BASE FIRE DEPARTMENT. ANDY ANDREWS (OUR ASSISTANT CHIEF) WAS ONE OF CHIEF TILLMAN'S FIREMEN AND I KNEW HE HAD "BUGGED" CHIEF TILLMAN FOR EVERYTHING IMAGINABLE. CHIEF TILLMAN CAME TO OUR OPEN HOUSE AND PURCHASED A CAKE. THE FUN BEGAN WHEN HE ASKED TO GO LOOK AT OUR EQUIPMENT. I TOLD HIM POINT BLANK THAT HE COULD NOT. HE THEN LAUGHED AND SAID "LOOK, I KNOW ANDY ANDREWS IS STEALING EVERYTHING HE CAN GET HIS HANDS ON." I TOLD HIM THAT AS LONG AS HE KNEW IT, WE WOULD GO LOOK BUT THAT IF HE "REPOSSESED" EVERYTHING THAT CAME FROM THE CHARLESTON AIR FORCE BASE FIRE DEPARTMENT, WE WOULD HAVE TO CLOSE DOWN. AT THAT TIME WE REALLY DIDN'T HAVE MUCH FROM THE CHARLESTON AIRBASE, BUT I SURE DIDN'T WANT TO TAKE ANY CHANCES.

THIS RELATIONSHIP WENT ON FOR MANY YEARS AND I BECAME A FRIEND OF CHIEF TILLMAN AND EVERY TIME THERE WAS A PIECE OF EQUIPMENT AVAILABLE AS SURPLUS, WE GOT A CALL. IT WAS UNREAL JUST HOW MUCH USABLE EQUIPMENT CHIEF TILLMAN ACQUIRED FOR US, NOT JUST FOR DISTRICT 1, BUT FOR ALL OF COLLETON COUNTY. MUCH OF THIS DID NOT COME FROM THE CHARLESTON ARIBASE BUT CHIEF TILLMAN WOULD HEAR OF SOMETHING THAT WE COULD USE AND HE WOULD GO OUT OF HIS WAY TO SEE THAT IT WAS MADE AVAILABLE TO US. I WOULD LIKE TO TELL OF SOME OF OUR TRIPS TO ACQUIRE SOME OF THIS EQUIPMENT BUT IN ORDER TO PROTECT THE "INNOCENT" SOME THINGS JUST CANNOT BE PRINTED.

CHIEF TILLMAN WAS A MAN THAT I WILL ALWAYS REMEMBER, NOT ONLY AS A FRIEND, BUT AS A COLLETON COUNTY RESIDENT THAT WAS SINCERELY INTERESTED IN THE COLLETON COUNTY FIRE SERVICE AND DID EVERYTHING IN HIS POWER TO HELP.

ANOTHER PIECE OF EQUIPMENT THAT CAME AVAILABLE BY JUST LETTING PEOPLE KNOW OF OUR NEEDS WAS OUR FIRST GENERATOR. MR. HOWARD HINES CALLED STEVE FRALIN

(ONE OF OUR FIREMEN) AND TOLD HIM THAT HE HAD A SMALL GENERATOR AT HIS FARM THAT HAD BEEN "ACQUIRED" AND WE WERE WELCOME TO IT. STEVE AND MYSELF WENT AND PICKED UP THIS GENERATOR, PAINTED IT RED, AND IT POWERED OUR LIGHTS AND SMOKE EJECTOR FOR YEARS. THIS WAS ANOTHER PIECE OF USABLE EQUIPMENT THAT WE WOULD NOT HAVE BEEN ABLE TO PURCHASE BECAUSE OF LIMITED FUNDS.


MR. JOE HICKMAN SOON BECAME THE CIVIL DEFENSE DIRECTOR AND WE BECAME FRIENDS AND HE IS ANOTHER PERSON THAT DID EVERYTHING IN HIS POWER TO PROMOTE THE FIRE SERVICE IN COLLETON COUNTY. NOT LONG AFTER BECOMING CIVIL DEFENSE DIRECTOR, MR. HICKMAN HAD TO ATTEND A MEETING IN COLUMBIA AND ASKED IF I WOULD LIKE TO RIDE WITH HIM AND VISIT THE STATE SURPLUS WAREHOUSE. THIS IS WHEN WE PURCHASED OUR FIRST SELF CONTAINED BREATHING APPARATUS. WHEN WE WALKED IN THE DOOR OF THE WAREHOUSE I SPOTTED TWO SCBA'S THAT HAD JUST BEEN PUT OUT FOR SALE FOR \$20.00 EACH. I WAS VERY GLAD TO BRING THESE BACK TO WALTERBORO. OUR FIRST NEW SCBA WAS PURCHASED APRIL 19. 1971 FROM CARL R. DICKERT COMPANY FOR \$242.75.

EARLY IN 1973 THERE WAS A VEHICLE ACCIDENT WHERE WE COULD HAVE USED A CUT-OFF SAW (ZIP SAW) TO EVERYONE'S ADVANTAGE. WE IMMEDIATELY PUT ACQUIRING THIS SAW A PRIORITY. WE RECEIVED SEVERAL DONATIONS AND PURCHASED OUR FIRST ZIP SAW MARCH 29, 1973 FROM READE EQUIPMENT FOR \$275.24. THE CITY FIRE DEPARTMENT PURCHASED THEIR FIRST ZIP SAW VERY SOON AFTER.

OUR FIRST REAL SMOKE EJECTOR WAS PURCHASED BY MR. & MR. CLYDE O. ACKERMAN. MRS. ACKERMAN HAD LEFT A POT ON THE STOVE AND IT FILLED THEIR HOUSE WITH SMOKE (8/22/73). WE HAD A FAN THAT HAD BEEN DONATED AND WE WERE USING IT FOR A SMOKE EJECTOR AND IT WAS DEFINITELY BETTER THAN NONE AT ALL BUT IT DID LEAVE A LOT TO BE DESIRED. I MENTIONED TO ONE OF THE FIREMEN THAT SOMEDAY WE WOULD HAVE A REAL SMOKE EJECTOR AND MR. ACKERMAN OVERHEARD MY COMMENT. HE IMMEDIATELY CALLED MRS. ACKERMAN AND TOLD HER TO GIVE ME A CHECK FOR "WHATEVER IT WAS THAT I WAS TALKING ABOUT". I



WE COULD PAY FOR IT. THIS CALL NOT ONLY GOT US A SMOKE EJECTOR BUT HELPED OUR MORALE QUITE A BIT AS WE AGAIN KNEW OUR EFFORTS WERE APPRECIATED.


MANY OTHERS HELPED US WITH MORALE (JUST GIVING US SUPPORT) WHEN THINGS GOT A LITTLE ROUGH. ONE OF THESE WAS MR. ROY GIBSON THE OWNER OF THE WALTERBORO DRIVE-IN THEATRE. BACK IN 1973 THE DRIVE-IN THEATRE WAS ONE OF THE FEW PLACES THE YOUNG FIREMEN (AND THEIR FAMILIES) COULD GO FOR ENTERTAINMENT. MR. GIBSON TOLD US THAT HE WOULD LET ALL OF THE FIREMEN AND THEIR FAMILIES IN THE DRIVE-IN FOR FREE IF THEY HAD IDENTIFICATION. THIS IS WHEN WE KNEW THE TIME HAD COME FOR US TO SECURE OUR FIRST RURAL FIRE DEPARTMENT BADGES AND WE KNEW WE HAD TO FIND A WAY TO MAKE THIS PURCHASE WITHOUT SPENDING MEMBERSHIP FUNDS. ONE OF OUR SUPPORTERS HAD MADE A DONATION OF \$50.00 FOR A SUPPER FOR THE FIREMEN AND WE USED THAT MONEY AND PAID THE BALANCE PERSONALLY. THESE BADGES WERE PURCHASED FROM PEARLMAN'S IN CHARLESTON AND SURE WERE SMALL COMPARED TO THOSE WORN TODAY, BUT THE DRIVE-IN THEATRE WAS ENJOYED BY ALL.

THE COLONIAL RESTURANT (LOCATED WHERE HARDEE'S IS NOW) OFFERED TO PROVIDE A STEAK SUPPER FOR US (AT A VERY REASONABLE PRICE). WE PLANNED THIS SUPPER FOR JANUARY 9, 1973 TO CELEBRATE THE END OF ANOTHER SUCCESSFUL YEAR. AT THIS SUPPER I RECEIVED ONE OF MY MOST PRIZED POSSESSIONS. THE FIREMEN PRESENTED ME WITH A PLAQUE RECONIZING ME AS THE FOUNDER OF THE COLLETON VOLUNTEER FIREMEN'S ASSOCIATION, INC., WHICH BECAME THE COLLETON RURAL FIRE DEPARTMENT AND IS NOW THE COLLETON COUNTY FIRE RESCUE. THIS HONOR WAS APPRECIATED MORE THAN THEY WILL EVER KNOW BUT I FELT THAT AS THERE WERE SO MANY OTHERS THAT HELPED MAKE FIRE PROTECTION A REALITY IN COLLETON COUNTY, SOMEHOW THEY SHOULD HAVE BEEN RECOGNIZED ALSO.


SOON AFTER OUR ORGANIZATION WE HAD SEVERAL OFFERS OF LAND ON WHICH TO BUILD A



ACKERMAN OFFERED TO HELP BUILD A STATION NEAR HIGHWAY 17A AND HIGHWAY 63, AND JOHN A (BUBBA) LUCAS, LEITH LUCAS, AND TOMMY JO NETTLES OF LUCAS REALTY DONATED A PARCEL OF PROPERTY TO THE COLLETON VOLUNTEER FIREMEN'S ASSOCIATION, INC. ON HIGHWAY 15N ACROSS FROM ASTEN MANUFACTURING COMPANY. THIS PROPERTY ACROSS FROM ASTEN MANUFACTURING COMPANY WAS THE BEST IN OUR OPINION AS WE KNEW ROBERTSON BLVD. WAS IN THE FUTURE PLANS AND WE FELT WE WOULD BE LOCATED WHERE WE COULD RESPOND ANYWHERE IN OUR DISTRICT WITHOUT GOING THROUGH THE CITY. WE SPENT MANY HOURS CLEANING THIS PROPERTY AND HAD GREAT PLANS FOR THIS LITTLE PIECE OF LAND THAT WAS DEEDED TO US DECEMBER 31, 1971.


HOWEVER, MRS. A. B. (EDITH) BROWN OWNED THE PROPERTY BEHIND US AND SHE OBJECTED TO OUR CLOSING AN OLD DIRT ROAD THAT WAS INCLUDED IN OUR DEED AND LOCATED BEHIND OUR PROPERTY. ON JANUARY 9, 1974 I RECEIVED A SUMMONS TO APPEAR BEFORE JUDGE W. L. RHODES, JR. IN HAMPTON AS OF JANUARY 19, 1974. MRS. BROWN WAS ASKING FOR AN INJUNCTION FOR NOT CLOSING THIS OLD DIRT ROAD AND FOR DAMAGES OF \$50,000.00 WITH THE LAW OFFICES OF SMOAK, HOWELL, BRIDGE, AND MOODY LAW FIRM INVOLVED. THIS WAS QUITE INTERESTING AS MR. WILLIAM T. HOWELL WAS REPRESENTING MRS. BROWN, MR. AUBURN BRIDGE WAS THE ATTORNEY FOR OUR ORGANIZATION AND MR. LEE RAY MOODY HANDLED THE DEED FROM LUCAS REALTY AND ALL WERE IN THE SAME LAW FIRM. I DID NOT HAVE TO APPEAR BEFORE JUDGE RHODES IN HAMPTON (I WAS TOLD HE HAD A HUNTING TRIP PLANNED THAT DAY) BUT WE HAD TO FORFEIT OUR RIGHTS TO THIS PROPERTY.

MANY YEARS PASSED AND WE REALIZED THAT OUR PRESENT LOCATION (ON HAMPTON ST) WORKED PRETTY WELL. ON DECEMBER 14, 1984, WE PURCHASED THIS PROPERTY FROM MR. GLEN STRICKLAND AND MR. JAMES R. GROOMS FOR \$55,000 AND RECIEVED A LOAN FROM FIRST FEDERAL OF WALTERBORO FOR \$40,000 AT THIRTEEN PERCENT INTEREST (13%).



PRESS AND STANDARD ARTICLE)

A RULING THAT THE CITY WOULD NOT RESPOND OUTSIDE THE CITY LIMITS AND THEN MAKE IT HARD FOR DEDICATED VOLUNTEER FIREMEN THAT WERE MAKING AN EFFORT TO HELP THEIR FRIENDS AND NEIGHBORS. HOWEVER, AT THAT TIME I WAS COMPLETELY UNAWARE OF THE JEALOUSLY THAT EXISTED WITHIN THE CITY ADMINISTRATION. THINGS DO SOMEHOW WORK OUT AS WE CONTINUED TO WORK TOGETHER AND PROVIDE MUTUAL AID, WHEN NECESSARY.

OUR FIRST MAJOR FIRE CALL CAME ABOUT 10:00 AM ON THE MORNING OF MARCH 30, 1970,

CALL STATED THAT LIGHTNING HAD STRUCK DOCTOR'S CREEK BAPTIST CHURCH AND THAT IT WAS ON FIRE BIG TIME. WE RESPONDED WITH OUR PUMPER, TWO TANKERS, AND REQUESTED HELP FROM THE CITY. WHEN WE WERE ABOUT A MILE ON BELLS HIGHWAY, WE COULD SEE SMOKE AND WE JUST KNEW THIS CHURCH WAS LOST.

HOWEVER, WITHIN ABOUT FIVE MINUTES AFTER WE MADE OUR ATTACK, ONE OF THE FIREMEN CAME TO ME (I WAS OPERATING THE PUMPER) AND STATED THAT THE FIRE WAS OUT. IT IS NO WAY I COULD EVER EXPRESS MY FEELINGS AT THAT TIME. THIS ONE FIRE WAS WORTH ALL OF THE HARD WORK THAT HAD GONE INTO ORGANIZING AND RAISING FUNDS TO PURCHASE OUR PUMPER. THERE WAS SOME SMOKE DAMAGE, VERY LITTLE WATER DAMAGE, AND THE FIRE DAMAGE WAS CONFINED TO ONE ROOM. THE TOTAL DAMAGE WAS LATER ESTIMATED AT SOME \$6,000.00.

FOR MANY MONTHS THE MEMBERS AND FRIENDS OF DOCTOR'S CREEK BAPTIST CHURCH WOULD EXPRESS THEIR APPRECIATION AND THAT WAS EVIDENT WHEN ONE OF THEIR MEMBERS FOUND OUT THAT THEIR INSURANCE COMPANY (SOUTHERN MUTURAL CHURCH) HAD NOT EVEN RECOGNIZED OUR EFFORTS. I WAS SOON CONTACTED BY THIS INSURANCE COMPANY AND ON JULY 2, 1971, SOME FIFTEEN MONTHS AFTER THE FIRE, WE RECEIVED A CHECK IN THE AMOUNT OF \$100.00.

THE FIRST MUTUAL AID CALL FROM THE CITY FOR OUR HELP CAME ON THE NIGHT OF DECEMBER 7, 1971 (DECEMBER 8, 1971 12:02 AM) AT THE STRIPE STORE ON EAST WASHINGTON STREET WHERE THE WATERFALL IS NOW. WE RESPONDED WITH OUR PUMPER AND TWELVE FIREMEN AND WERE VERY GLAD TO HAVE BEEN OF ASSISTANCE TO THE CITY.

ONE FIRE LOSS THAT WE ALL DEEPLY REGRETTED WAS THE ACADEMY ROAD BAPTIST CHURCH.
ON MONDAY, JANUARY 21, 1974, AT ABOUT 7:30 PM, WE RECEIVED A CALL THAT THIS CHURCH WAS BURNING. WE RESPONDED WITH OUR PUMPER, AND TWO TANKERS, AND THE CITY FIRE DEPARTMENT RESPONDED WITH A PUMPER. HOWEVER, UPON OUR ARRIVAL THE BUILDING WAS FULLY INVOLVED AND ALREADY A COMPLETE LOSS. THIS BUILDING HAD BEEN CON-


ACADEMY ROAD BAPTIST CHURCH 1/21/74

STRUCTED AROUND 1912 AND HAD SERVED AS THE CATHOLIC CHURCH IN WALTERBORO AND HAD BEEN MOVED FROM HAMPTON STREET SOME EIGHT YEARS BEFORE. SERVICES HAD BEEN HELD ON SUNDAY AND NO ONE SHOULD HAVE BEEN IN THE CHURCH ON MONDAY (SEE ARTICLE FROM THE PRESS & STANDARD 1/24/74).

WE PARTICULARLY REGRETTED THIS LOSS AS WE WERE TOLD THAT THEIR TOTAL MEMBERSHIP WAS ONLY ABOUT A HUNDRED AND THEY HAD JUST PURCHASED AN ORGAN, A NEW PIANO, AND SOME NEW PEWS AND PROBABLY DID NOT ENOUGH INSURANCE TO COVER THEIR LOSS. WE NEVER DETERMINED THE CAUSE OF THIS FIRE OR WHY THERE WAS A FIVE GALLON CAN INSIDE THE BUILDING.

AS WE NOW HAD A WORKING ORGANIZATION WITH, WHAT WAS AT THAT TIME, ADEQUATE EQUIPMENT WE FELT WE SHOULD SOMEHOW IMPROVE OUR RESPONSE TIME BY BEING ABLE ABLE TO CONTACT THE FIREMEN IN A MORE TIMELY MANNER. AT THIS TIME THE CITY HAD A LIST OF FIREMEN FROM THE RURAL DEPARTMENT AND WHEN A CALL WAS RECEIVED, THE CITY FIRE DEPARTMENT ON DUTY PERSONNEL WOULD CONTACT THE FIRST AVAILABLE PERSON ON THE LIST. IT WOULD THEN BECOME THE RESPONSIBILITY OF THAT PERSON (RURAL FIREMAN) TO MAKE CONTACT WITH THE REST OF THE RURAL FIREMEN. WITH TIME LOST IN RESPONDING TO CALLS IN THIS MANNER, I STILL DO NOT UNDERSTAND HOW WE WERE SAVING THOUSANDS OF DOLLARS WORTH OF PROPERTY EVERY MONTH.

EARLY IN 1975 WE RECEIVED WORD THAT THERE WOULD BE SOME FUNDS AVAILABLE UNDER THE RURAL DEVELOPMENT ACT OF 1972, ADMINISTERED BY THE S. C. STATE COMMISSION OF FORESTRY THAT POSSIBLY WOULD HELP US PURCHASE SOME COMMUNICATION EQUIPMENT. THIS WOULD BE A MATCHING FUND GRANT (WE WOULD HAVE TO PROVIDE ONE-HALF OF THE FUNDS). THERE WAS NO WAY THAT WE COULD EVEN AFFORD THAT BUT WE APPLIED FOR A GRANT OF \$3000.00 ON MAY 22, 1975, AND WERE NOTIFIED THAT THIS GRANT HAD BEEN APPROVED ON JULY 15, 1975. (SEE LETTER FROM S. C. COMM. OF FORESTRY) WE THEN KNEW WE HAD TO WORK FAST OR WE WOULD LOSE THIS MONEY. I CONTACTED MR. E. R. "TUCK" MCCONNELL. THE CITY MANAGER OF WALTERBORO AT THAT TIME AND WE CAME TO AN

AGREEMENT THAT WOULD HELP BOTH THE CITY AND THE RURAL FIRE DEPARTMENTS.

THE CITY FIRE DEPARTMENT WAS ALERTED AT THE TIME OF A FIRE BY A SIREN THAT WAS MOUNTED ABOVE THE ROOF OF CITY HALL AND SOME FORTY TELEPHONES THAT RANG SIMULTANEOUSLY AT THE HOME AND BUSINESS OF THE FIREMEN. IF YOU WERE AWAY FROM THE TELEPHONE AND DID NOT HEAR THE SIREN, YOU MISSED THE FIRE.

THE AGREEMENT REACHED BY MYSELF AND MR. MCCONNEL WAS AS FOLLOWS:

- 1. PAGERS WERE TO BE PURCHASED, 15 FOR CITY USE AND 1 FOR RURAL USE.
- 2. AN ENCODER (THE EQUIPMENT THAT ACTIVATED THE PAGERS) WOULD BE PUR-CHASED AND INSTALLED ON THE CITY BASE RADIO AT CITY HALL FOR USE BY BOTH DEPARTMENTS.

THE TOTAL COST OF THIS WOULD BE \$5,780.15 WITH THE CITY RECEIVING USE OF \$5,454.64 WORTH OF EQUIPMENT FOR \$3,000.00. THE DIFFERENCE BEING THE ONE PAGER (\$325.51) TO BE USED BY THE RURAL FIRE DEPARTMENT. EVEN THOUGH THE CITY ACTUALLY RECEIVED THE AMOUNT OF \$2,454.64 OF OUR GRANT FUNDS, THIS GAVE US THE USE OF A BASE RADIO AND TONE-OUT CAPABILITY FOR OUR PAGERS. IT WAS A GREAT IMPROVEMENT FOR BOTH DEPARTMENTS, WHEN ON JANUARY 13, 1976, THESE PAGERS WERE PUT IN SERVICE.

FOR SOME FIVE YEARS THE RURAL FIRE DEPARTMENTS GOT ABSOLUTELY NO FUNDS FROM COLLETON COUNTY BUT WERE EXPECTED TO RESPOND TO ANY COUNTY PROPERTY SUCH AS SCHOOLS, MAINTENANCE BUILDINGS, DUMPSTERS, ETC. THIS SOON BECAME A PROBLEM WITH THE VOLUNTEERS WHO WERE ANSWERING THESE CALLS. IN 1973 WE MADE CONTACT WITH SENATOR J. P. HARRELSON AND MADE HIM AWARE THAT WE MAY HAVE TO STOP ANSWERING THESE CALLS AS THE COUNTY DID NOT PAY A MEMBERSHIP AND WOULD NOT HELP US IN ANY WAY (SUCH AS BRINGING US A LOAD OF DIRT TO FILL HOLES IN FRONT OF OUR STATION). IN JUST A FEW DAYS SENATOR HARRELSON CONTACTED ME AND STATED THAT HE WOULD REQUEST SOME REVENUE SHARING FUNDS FOR US BUT WE WOULD HAVE TO ELECT A COMMITTEE FROM ALL FIRE DEPARTMENTS CONCERNED AND WOULD HAVE TO ANSWER ALL CALLS TO COUNTY PROPERTY AND GIVE CONSIDERATION TO ANSWERING CALLS TO HIGHWAY ACCIDENTS (THIS WE WERE DOING ANYWAY). THESE WERE TO ASSESS THE NEEDS OF EACH FIRE DEPARTMENT AND DECIDE JUST HOW THESE FUNDS WOULD BE DISTRIBUTED. WE DID NOT HAVE TO DISTRIBUTE THEM EQUALLY AS SOME DEPARTMENTS WERE JUST GETTING STARTED AND NEEDED HELP MORE THAN OTHERS. WE RECEIVED \$5,000.00 IN 1974 AND AGAIN IN 1975. IT WAS UNREAL HOW MUCH THESE FUNDS HELPED THESE DEPARTMENTS WITH INSURANCE, REPAIRS, EQUIPMENT, ETC. WE RECEIVED NO MORE FUNDS FROM COLLETON COUNTY UNTIL ELECTION TIME IN MAY, 1979 WHEN PEDON B. MCLEOD AUTHORIZED ANOTHER \$5,000.00 FOR OUR USE. THESE FUNDS (1979) WERE DIVIDED AND CHECKS WERE SENT TO THE DIFFERENT DEPARTMENTS TO BE USED AS NEEDED.

IT WOULD BE VERY UNFAIR TO LEAVE OUT THE OFFICE OF CIVIL DEFENSE (NOW THE EMERGENCY PREPAREDNESS AGENCY) FOR THEIR HELP IN SECURING SEVERAL GOOD PIECES OF EQUIPMENT. IN MY OPINION, THE MOST UTILIZED PIECE OF EQUIPMENT THAT WAS SECURED BY THEM FOR OUR USE WAS "BERTHA". OF COURSE WATER SUPPLY IS ALWAYS A MAJOR CONCERN IN THE RURAL AREAS WHERE THERE ARE NO FIRE HYDRANTS. ONE SUNDAY AFTERNOON IN JUNE OF 1972 I RODE DOWN TO THE CITY OF COOSAWHATCHIE AND STOPPED BY THE FIRE DEPARTMENT. I NOTICED A LARGE TANKER PARKED IN A FIELD AND IT LOOKED ABANDONED. STEVE FRALIN (ONE OF THE VOLUNTEER FIREMEN), HIS WIFE, AND MY SON JIMMY, WERE WITH ME AND WE FELT WE SHOULD CHECK AND SEE IF MAYBE WE COULD SECURE THIS PIECE OF EQUIPMENT FOR OUR USE. I MADE SEVERAL CONTACTS AND FOUND THAT IT WAS ACTUALLY OWNED BY THE CIVIL DEFENSE AND LOANED TO THE COOSAWHATCHIE FIRE DEPARTMENT MANY MONTHS BEFORE. I IMMEDIATELY MADE CONTACT

WITH MR. JOE HICKMAN, THE COLLETON COUNTY CIVIL DEFENSE DIRECTOR, AND REQUESTED HIS HELP. AFTER SEVERAL WEEKS OF PHONE CONTACTS, THIS TANKER WAS IN WALTERBORO.

ALL EQUIPMENT OWNED BY CIVIL DEFENSE HAD TO BE ACCOUNTED FOR AND AS I HAD THIS TANKER THE AUDITOR CONTACED ME IN OCTOBER OF 1973 AND I MET WITH HIM TO VERIFY THAT THIS UNIT WAS BEING USED AS INTENDED. HE (I SURE WISH I KNEW HIS NAME) HAD A GREAT INTEREST IN FIRE DEPARTMENTS AND SPENT A LOT OF TIME WITH US. HE MADE ONE STATEMENT THAT REALLY PAID OFF. "IF I CAN EVER BE OF HELP TO YOU FOLKS, JUST LET ME KNOW". I IMMEDIATELY TOLD HIM WE NEEDED A TRACTOR TO PULL THIS TANKER AND WE WANTED ONE IN GOOD CONDITION. HE SAID THAT HE KNEW OF ONE THAT WOULD BE AVAILABLE IN THE NEXT FEW MONTHS AND THAT HE WOULD TRY TO SECURE IT FOR US. OF COURSE, I NEVER EXPECTED TO HEAR FROM HIM AGAIN UNTIL THE NEXT EQUIPMENT AUDIT. BUT TO MY SURPRISE, JOE HICKMAN CALLED AND INFORMED ME THAT WE A HAD A TRACTOR BUT IT WAS IN ATLANTA. IN JUNE OF 1974, (I SIGNED FOR IT JUNE 10, 1974) JOE HICKMAN, ALFRED ANDREWS AND I LEFT WALTERBORO AT MIDNIGHT AND ARIVED IN ATLANTA JUST AS THE SURPLUS COMPOUND OPENED. THE ATTENDANT TOLD US THAT THIS WAS A GOOD TRUCK BUT SOMEONE HAD ROBBED THE DISTRIBUTOR CAP. I JUST HAPPENED TO HAVE ONE WITH ME AND WE DROVE THIS TRACTOR BACK TO WALTERBORO. THIS UNIT SERVED THIS COUNTY WELL AND WAS TAKEN OUT OF SERVICE JUST A FEW YEARS AGO.

IN 1974 MR. E. R. "TUCK" MCCONNEL, THE WALTERBORO CITY MANAGER, INFORMED ME
THAT ORANGEBURG WAS IN THE PROCESS OF PURCHASING A NEW FIRE ENGINE AND THAT
IN THE NEXT FEW MONTHS A USED TRUCK MAY BE FOR SALE. MR. HERMAN L. (JACK) MOCK AND
I DROVE TO ORANGEBURG AND WHEN WE SAW THIS PUMPER WE FELT IT WOULD BE GOOD
FOR RURAL USE BECAUSE IT HAD A FRONT MOUNTED PUMP THAT WOULD BE GREAT FOR
DRAFTING. THIS TRUCK BECAME AVAILABLE TO THE HIGHEST BIDDER ONLY A FEW MONTHS
LATER AND WE DID NOT THINK WE HAD A CHANCE OF GETTING IT AS WE ONLY HAD TWO THOUSAND DOLLARS TO SPARE. ANYWAY, WE MADE THEM AN OFFER OF TWO THOUSAND AND TEN
DOLLARS AND WE PURCHASED THIS UNIT ON DECEMBER 20, 1974. THE TEN DOLLARS MADE US

THE HIGH BIDDER. THIS UNIT SERVED DISTRICT 1 FOR MANY YEARS AND WAS LATER SOLD TO THE CANADYS DISTRICT. THE PURCHASE OF THIS UNIT MADE IT POSSIBLE FOR US TO TRANSFER A TRUCK (THE FIRST TANKER) TO THE HENDERSONVILLE DISTRICT.

OUR CALLS TO WOODS AND GRASS FIRES, DUMPSTER FIRES, WRECKS, ETC. WERE INCREAS-ING DRASTICALLY AND THE PUMPER THAT HAD BEEN PURCHASED IN OCTOBER OF 1969 WAS BECOMING OVERWORKED. WE NOW HAD EVERYTHING PAID FOR AND HAD A FEW DOLLARS IN THE BANK THAT WAS NOT OBLIGATED. WE KNEW THAT WE NEEDED ANOTHER PUMPER BUT WE ALSO FELT WE COULD NOT AFFORD IT. ON JANUARY 13, 1976 THE REPRESENTATIVE FROM CARL R. DICKERT CO. OF PIEDMONT, S. C. STOPPED BY MY PLACE OF BUSINESS DRIVING A EMERGENCY ONE MINI-PUMPER AND OFFERED TO GIVE US A DEMONSTRATION THAT NIGHT AS WE HAD A MEETING SCHEDULED. WE FELT THE PURCHASE OF THIS UNIT WOULD SERVE OUR PURPOSE WHERE WOODS FIRES, VEHICLE FIRES, ETC. WERE CONCERNED AND HELP TO KEEP MILES OFF OUR FULL SIZE PUMPER. WE MADE A DOWN PAYMENT OF \$5,000.00 AND SECURED A LOAN FOR \$11,320.00 AND GAVE THE SALES REPRESENTATIVE FROM CARL R. DICKERT CO. A RIDE HOME THE NEXT DAY. THAT WAS PROBABLY HIS EASIEST SALE OF THE YEAR BUT THAT MINI-PUMPER SERVED OUR NEEDS FOR MANY YEAR AND WAS LATER SOLD TO THE RUFFIN DISTRICT. THIS PURCHASE ALLOWED US TO TRANSFER ANOTHER TANKER TO THE HENDERSONVILLE DISTRICT.

AT THE VERY BEGINNING ONE OF OUR GOALS WAS TO GET A LOWER INSURANCE RATING FOR ALL PROPERTY SERVED BY OUR DISTRICT. THIS WAS VERY DIFFICULT AS WE HAD TO ANSWER ALL CALLS IN OUR COVERAGE AREA IN ORDER TO QUALIFY. WE HAD APPROXIMATELY ONE-HALF OF THE PROPERTY COVERED WITH OUR MEMBERSHIP PLAN IN 1975, AND HAD A GOOD WORKING ORGANIZATION. IT WAS A VERY DIFFICULT DECISION BUT WE AGREED TO ANSWER ALL CALLS IN ORDER TO SECURE LOWER INSURANCE PREMIUMS FOR OUR MEMBERS AND FELT THAT MAYBE THIS WOULD GET OTHER PROPERTY OWNERS TO JOIN WITH US. WE THEREFORE, JULY 8, 1975, CONTACTED MR. RONALD C. SELF, WITH THE INSURANCE SERVICES OFFICE (ISO) IN COLUMBIA AND INFORMED HIM THAT WE WERE NOW RESPONDING TO ALL

CALLS WITHIN OUR DISTRICT. A LETTER TO ME, DATED AUGUST 15, 1975, STATED THAT WE HAD RECIEVED OUR CLASSIFICATION. THIS WAS GREAT, WE KNEW WE COULD NOW SAVE THE PROPERTY OWNERS MUCH MORE THAN THE MEMBERSHIP CHARGES WITH THE DECREASE IN INSURANCE PREMIUMS. WE WERE TO HAVE A PROTECTION CLASS 8 WITHIN THREE MILES OF OUR STATION AND 1,000 FEET OF A FIRE HYDRANT. PROTECTION CLASS 9 WOULD APPLY WITHIN THREE MILES OF THE STATION WITHOUT A FIRE HYDRANT AND OVER THREE MILES WITH OR WITHOUT A HYDRANT WOULD BE CLASS 9A. INSURANCE AGENTS STRONGLY OBJECTED TO THIS. AS LOWERING THE INSURANCE RATES, LOWERED THEIR COMMISSIONS. IN A SHORT TIME WE REALIZED THAT MANY AGENTS WERE WRITING LOWER PREMIUMS TO PROPERTY OWNERS THAT DID NOT HAVE OUR COVERAGE. AS THE WORD REACHED OUR RESIDENTS AND PROP-ERTY OWNERS THAT YOU WOULD GET THE INSURANCE PREMIUM REDUCTION, EVEN IF THEY HAD NOT PAID DUES TO OUR ORGANIZATION, OUR CASH FLOW BEGAN TO DECREASE AND WE LOST MANY OF OUR LONG TIME MEMBERS. INFLATION ALSO WAS HURTING OUR ORGANIZATION AND WE DID NOT WISH TO INCREASE THE MEMBERSHIP DUES. WE WERE ANSWERING MORE CALLS EVERY YEAR AND EVERYTHING THAT WE PURCHASED WAS COSTING US MORE AND MORE EACH YEAR. WE KNEW WE HAD TO DO SOMETHING TO STAY IN BUSINESS, BUT WE HAD FEW OPTIONS.

OPTIONS:

- The City can accept the proposal of the Rural Fire Department.
- Because of a lack of funds, the Bural Fire Department can cease to operate.
- 3. A special taxing district could be set up whereby a millage is applied to all property under the protection of the Eural Fire Department. This would allow them to answer all calls in the area and pay for it through County taxes in the same manner as the City Fire Department is supported. It is estimated that this would require a tax increase of between nine (9) to twenty (20) skills. Politically, this proposal probably hasn't got a chance.
- 4. The Eural Fire Department can drop its policy whereby it answers all calls in its District. This would mean that the Rural Fire Department would respond only to calls from houses that had payed the annual fee. Those home owners who did not think enough of their property to pay the annual fee would not have their home protected and the department would not respond. Except for the fact that firemen don't like to watch houses burn, this appears to be the best solution at this time.

CONCLUSION: We think the Burel Fire Department is a dedicated group of volunteers which parform necessary services in an excellent namer. As you know, the City has not charged the Burel Fire Department for water use, dispatching services, and related frems. We provide back-up for any major fires the Burel Fire Department may have and they do the same for us. However, our responsibility is to the citizens of Walterboro and to its orderly growth. Anything that will inhibit this growth should be avoided. If there is any way we can assist the Burel Fire Department with its problem without burting our selves, we feel it should be done. However, we would hope you would not agree to this proposal in its present form.

PUBLIC WORKS ALLOCATIONS DISAPPOINT LOCAL OFFICIALS

Economic Development Administration (EDA) allocations to Lowcountry governments under Round II of the Local Public Works Act have left some municipal and county governments confused, upset and penniless.

According to information from EDA, the city of Beaufort is the only jurisdiction in the Lowcountry which will receive funds under the newly enacted \$4 billion program. That allocation is approximately \$1.2 million. Other governments were apparently hurt by projects which were funded in Round I of Public Works a few months ago.

Still, however, there are amaxing discrepancies between the guide-lines published earlier by EDA and the manner in which allocations were actually arrived at. The most glaring example involves Jasper County, which received no Round II allocation despite having an unemployment rate greater than 11 per cent. Allocations were to be based both on number of unemployed and percentage of unemployment, with the amount of any project approved in Round I then deducted from the Round II allocation. Colleton and Hampton Counties received allocations of only \$220,000 and \$72,000 respectively However, a \$560,000 project approved in Round I knocked Colleton County's allocation down to zero. Hampton County governments, on the other hand, apparently fell victim to a Round II rule that no project under \$75,000 would be allowed. Beaufort County, too, had received a Round II allocation, but that was also erased by a project

INTERESTED CITIZENS FROM THE JACKSONBORO AREA MET IN EARLY 1970 (I DO NOT HAVE THE
EXACT DATE) AND THE FOLLOWING WERE ELECTED: JAMES E. BESSINGER, CHAIRMAN, H. B.
HUDSON, CO-CHAIRMAN, J. L. MCMILLAN, TREASURER, H. B. HUDSON, SECRETARY, WITH S. G.
DREW, MOSES GIBSON, DICKIE GODLEY, BOB HUNTER, FLETCHER MOODY, REV. JAMES RILEY,

AND JOE WASHINGTON. THIS WAS THE FIRST BOARD OF DIRECTORS FOR THE JACKSONBORO DISTRICT (COLLETON FIRE PROTECTION DISTRICT NO. 2).

IN SEPTEMBER 0F 1969 WHEN THE WALTERBORO DISTRICT RECEIVED A SCHOOL BUS TANK TRUCK FROM THE DEPARTMENT OF EDUCATION IN COLUMBIA, WE WERE ALSO ABLE TO SECURE A 1962 DODGE TANK FOR USE ANYWHERE IN COLLETON COUNTY. THIS UNIT WAS GIVEN TO JACKSONBORO. I ALWAYS WONDERED IF I DID JACKSONBORO A FAVOR BY SECURING THIS TRUCK FOR THEM AS IT WAS A PIECE OF JUNK IN MY OPINION. HOWEVER, THEY INSTALLED A PUMP, HOSE, AND PAINTED IT RED (PAINT SURE COVERED A LOT) AND IT SERVED THE JACKSONBORO AREA FOR MANY YEARS.

IT WAS MANY YEARS BEFORE JACKSONBORO HAD, IN MY OPINION, A GOOD WORKING ORGANIZATION DUE TO LACK OF INTEREST BY MOST OF THE POPULATION AND TO THE LIMITED NUMBER OF RESIDENTS IN THE AREA SERVED. ONLY RECENTLY DID THE INTEREST INCREASE TO THE POINT THAT I FELT THERE WAS ADEQUATE FIRE PROTECTION IN THE JACKSONBORO AREA.

MR. FRANK JUMPER BECAME THE FIRST CHIEF AND WORKED MANY LONG AND HARD HOURS TRYING TO PROVIDE ADEQUATE FIRE PROTECTION WITH LIMITED RESOURCES. AS MANY OF THE FIRST FIREMEN ARE STILL MEMBERS OF THIS DEPARTMENT, I FEEL THERE WAS AND STILL IS, A LOT OF COMMUNITY INTEREST WHERE THE FIRE SERVICE IS CONCERNED. THIS DEPARTMENT HAD GOOD AND BAD YEARS BUT AS OF THIS DATE THIS DEPARTMENT IS DOING GREAT MAINLY BECAUSE OF A GRANT THAT BUILT A NEW STATION AND PURCHASED A NEW PUMPER.

RUFFIN-DISTRICT 4

A LITTLE REMEMBERED FACT WAS THAT MR. T. H. HYDRICK, SR. WAS RESPONSIBLE FOR THE FIRST MEETING TO DISCUSS FIRE PROTECTION FOR THE RUFFIN AREA. I DO NOT REMEMBER JUST WHAT PROMPTED THIS BUT MR. HYDRICK AND I HAD BEEN FRIENDS FOR MANY YEARS AND HE HAD BEEN FOLLOWING THE PROGRESS OF THE RURAL FIRE DEPARTMENTS. WE DECIDED TO ADVERTISE A MEETING IN ORDER TO KNOW IF THERE WAS ENOUGH INTEREST

IN THE RUFFIN AREA TO ORGANIZE A FIRE DEPARTMENT. A LARGE ADD APPEARED IN THE PRESS & STANDARD ON NOVEMBER 11, 1971, URGING THE CITIZENS IN THE RUFFIN AREA TO ATTEND A MEETING AT THE RUFFIN HIGH SCHOOL ON NOVEMBER 17, 1971. A LARGE GROUP OF CITIZENS ATTENDED AND A BOARD OF DIRECTORS CONSISTING OF J. W. (JACK) BEVERLY, CHAIRMAN, LEON BRYANT, JR., VICE-CHAIRMAN, LANDIS CARTER, SECRETARY & TREASURER, WITH OTHER BOARD MEMBERS, GERALD BRELAND AND MARSHALL RYAN, WERE ELECTED. A SHORT TIME LATER LEON BRYANT, JR. RESIGNED AND WAS REPLACED BY W. P. LLOYD. ORGANIZATION PROCEDURES AND FUND RAISING BEGAN IMMEDIATELY AND IN MAY OF 1972 A SCHOOL BUS TANK TRUCK WAS PURCHASED FROM THE DEPARTMENT OF EDUCATION IN COLUMBIA. MR. J. W. (JACK) BEVERLY AND I HAD THE HONOR OF GOING TO COLUMBIA AND BRINGING THIS TRUCK TO COLLETON COUNTY. THIS TRUCK HAD A PUMP INSTALLED IN WALTERBORO ALONG WITH HOSE AND OTHER EQUIPMENT AND ON JULY 1, 1972. THIS TRUCK RECEIVED A HUGE WELCOME IN THE RUFFIN COMMUNITY. (SEE ARTICLE FROM PRESS & STANDARD). THIS TRUCK WAS FIRST HOUSED IN RUFFIN IN A BUILDING OWNED BY A MR. CUMMINGS (SURE WISH I COULD REMEMBER HIS FIRST NAME) AND LATER MOVED TO HERNDON'S SERVICE STATION AT BELLS AND THEN TO JACK BEVERLY'S ON AZALEA PATCH ROAD. MR. JACK BEVERLY WAS ELECTED AS THE FIRST FIRE CHIEF OF THE RUFFIN DISTRICT ON APRIL 25, 1972 AND HE WORKED TIRELESSLY FOR MANY YEARS TRYING TO CREATE ENOUGH INTEREST TO HAVE ADEQUATE FIRE PROTECTION IN THE RUFFIN AREA. AFTER SEVERAL YEARS OF WANING INTEREST AND LACK OF FUNDING, THE RUFFIN FIRE DEPARTMENT ALMOST CEASED TO EXIST. HOWEVER, TODAY WITH A STATION ON AZALEA PATCH ROAD AND ON THE BELLS HIGHWAY, THIS FIRE DEPARTMENT SHOULD BE THE PRIDE OF THE COMMUNITY.

CANADYS DISTRICT 5

THIS DISTRICT GOT OFF TO A GREAT START WHEN ON MARCH 8, 1972 MR. CECIL HIOTT HAD A MAJOR FIRE AND DISTRICT 1 RESPONDED. THIS LET PEOPLE IN THE CANADYS AREA KNOW THAT FIRE PROTECTION WAS NEEDED. LATER IN MARCH OF 1972, SOME 40 PERSONS FROM THE CANADYS COMMUNITY GATHERED AT THE COUNTY AGRICULTURAL BUILDING TO DIS-

CUSS ORGANIZING A FIRE DEPARTMENT. THE MEMBERS OF THE WALTERBORO DISTRICT HAD ITS TRUCKS AND EQUIPMENT OUTSIDE TO SHOW FIRST HAND JUST WHAT HAD BEEN ACCOMPLISHED BY THE WALTERBORO DISTRICT. THIS GROUP IMMEDIATELY SELECTED ITS BOARD OF DIRECTORS AND STARTED FUND RAISING. THE FIRST BOARD OF DIRECTORS WAS: VERNON R. ROBINSON, CHAIRMAN, WILLIAM (BILL) FRAZIER, VICE-CHAIRMAN, MISS DORIS E. BAILEY, SECRETARY & TREASURER, WITH JAMES M. WESTBURY AND JAY G. ADAMS AS THE OTHER BOARD MEMBERS. IN THE NEXT FEW YEARS THEY OBTAINED A SCHOOL BUS TANK TRUCK, PURCHASED A USED PUMPER FROM CHARLESTON, AND SECURED THE OLD SCHOOL PROPERTY FOR A STATION. BUT SOMEHOW MR. VERNON ROBINSON (THE FIRST CHIEF) JUST COULD NOT DO EVERYTHING THAT WAS EXPECTED AND NEEDED AND SOON THIS DEPARTMENT BEGAN TO FAIL DUE TO LACK OF INTEREST AND FUNDING. TODAY, BEING COUNTY SUPPORTED, THIS DISTRICT SEEMS TO BE DOING GREAT AND THIS PLEASES ME TO NO END.

GREENPOND DISTRICT 6

THIS DISTRICT BEGAN WHEN FOUR RESIDENTS OF THE GREENPOND COMMUNITY DECIDED THAT THE TIME HAD COME FOR SOME TYPE OF FIRE PROTECTION IN THE GREENPOND AREA. THESE MEN, RICHARD WOOD, H. S. MCMILLAN, C. M. DANTZLER, AND ELLIS BROWN HAD LOCATED A USED TEXACO GAS TRUCK IN CHARLESTON, GONE TO THE BANK, BORROWED THE FUNDS TO MAKE THE PURCHASE, AND MADE ARRANGEMENTS TO GET THIS TRUCK TO GREENPOND. ON SATURDAY, JUNE 24, 1972, I HAD THE HONOR OF GOING TO CHARLESTON AND DRIVING THIS TRUCK TO RICHARD WOOD'S RESIDENCE IN GREENPOND. SOON AFTER, A LETTER WAS SENT TO THE RESIDENTS OF GREENPOND TO LET THEM KNOW THAT AN EFFORT WAS BEING MADE TO ORGANIZE A FIRE DEPARTMENT.

IT IS HARD TO BELIEVE THAT AFTER THESE FOUR MEN WENT WAY BEYOND THE CALL, THEY WERE CRITICIZED "FOR TRYING TO TAKE OVER". HOWEVER, YOU REALLY HAD TO CONSIDER WHO WAS DOING THE CRITICIZING. I ATTENDED ONE OF THE FIRST MEETINGS AFTER THIS TRUCK HAD BEEN PURCHASED AND BROUGHT TO GREENPOND AND I WAS VERY PLEASED BY JUST HOW MUCH SUPPORT THIS GROUP HAD.

SOON AFTER THIS MEETING, THE FIRST BOARD OF DIRECTORS WAS ELECTED WITH H. S. MCMILLAN, CHAIRMAN, DEWEY JOHNS CO-CHAIRMAN, C. M. DANTZLER, TREASURER, AND RICHARD WOOD, SECRETARY. THE OTHER BOARD MEMBERS WERE BARNEY RITTER, ANDERSON GRANT, ELLIS BROWN, BILLY BALDWIN, ASHLEY PELLUM, ARTHUR STEWART, AND JIMMY POOLE.

IMMEDIATELY, WORK BEGAN TO EQUIP THIS TRUCK AND MAKE IT AVAILABLE FOR FIRE CALLS.

A PUMP WAS PURCHASED AND I WOULD LOVE TO HAVE A RECORDING OF C. M. DANTZLER AND RICHARD WOOD INSTALLING IT. I WAS TOLD THAT THEY KEPT ARGUING ABOUT WHO WOULD WORK AND WHO WOULD FIGHT THE MOSQUITOES.

EFFORTS OF ALL REALLY PAID OFF APRIL 29, 1975 WHEN A CALL WAS RECEIVED (4.45 PM) FROM POCO SABO PLANTATION THAT THERE WAS A FIRE AT THE MAIN HOUSE. UNITS FROM DISTRICT 1 (WALTERBORO) ALSO RESPONDED AND THE BUILDING WAS SAVED THANKS TO THE GREEN-POND FIRE DEPARTMENT. THIS WAS A GREAT MORALE BOOSTER FOR ALL.

RICHARD WOOD BECAME THE FIRST FIRE CHIEF AND SERVED FAITHFULLY FOR MANY YEARS.

THE FIRST FIRE STATION (TORN DOWN IN 2006) WAS LOCATED BEHIND THE HEALTH DEPARTMENT WHICH IS NOW A PART OF GREENPOND BAPTIST CHURCH.


SMOAKS-DISTRICT 7

THE TOWN OF SMOAKS HAD BEEN INTERESTED IN FIRE PROTECTION FOR MANY YEARS AS THE TOWN ADMINISTRATION HAD MONIES SET ASIDE FOR THIS PURPOSE. HOWEVER, ON FEBRUARY 8, 1972 MRS. BETTY ROGERS BROWN MOYE DIED WHEN HER HOME BURNED. STEVE FRALIN AND WAYNE KUBIK OF THE COLLETON RURAL FIRE DEPARTMENT (DISTRICT 1) RESPONDED WITH A TRUCK AND HER BODY WAS RECOVERED.

VERY SOON AFTER THIS INCIDENT, I RECEIVED A CALL AND WAS ASKED TO MEET WITH SOME
OF THE FOLKS IN SMOAKS CONCERNING ORGANIZING A FIRE DEPARTMENT. WE REALLY
DIDN'T KNOW WHAT TO EXPECT AS THE ONLY ONE IN THIS GROUP THAT WE KNEW WAS MR.

PAUL FENDER. HERMAN L. (JACK) MOCK AND I MET WITH THEM AND FOUND THAT THESE FOLKS WERE DEFINITELY READY FOR FIRE PROTECTION IN THE SMOAKS AREA.

WITHIN A VERY SHORT PERIOD OF TIME MAYOR CLIFFORD ROBERTSON INVITED ME BACK TO SMOAKS TO SEE THEIR NEW STATION AND FIRE TRUCK (LOCATED AT WHAT IS NOW FIREMAN LANE AND SUNRISE ROAD). EVEN THOUGH SMOAKS DID NOT OPERATE UNDER OUR CHARTER (COLLETON VOLUNTEER FIREMEN'S ASSOC.) I DID EVERYTHING IN MY POWER TO HELP THEM AND WAS ABLE TO SECURE A TRUCK THROUGH CIVIL DEFENSE ON WHICH THEY MOUNTED A TANK FOR WATER SUPPLY.

THE FIRST CHIEF WAS MR. JAMES CARLISLE AVANT, SR. LATER, MR. JOHN GRAHAM, (WHO STILL SERVES AS AN ACTIVE MEMBER OF THE DEPARTMENT) BECAME CHIEF AND WAS CHIEF WHEN COLLETON COUNTY ASSUMED JURISDICTION ONLY A FEW YEARS AGO.

HENDERSONVILLE-DISTRICT 8

SEVERAL OF THE RESIDENTS IN THE HENDERSONVILLE AREA WERE VOLUNTEERS WITH DISTRICT 1, AS THEY WORKED AROUND WALTERBORO. THEREFORE, THEY KNEW FIRST HAND THAT A LOT OF GOOD THINGS COULD HAPPEN IF FIRE PROTECTION WAS AVAILABLE IN THE RURAL AREAS. ON JULY 22, 1974, 31 PERSONS ATTENDED A MEETING AT THE HENDERSONVILLE ELEMENTARY SCHOOL TO DISCUSS THE ORGANIZATION OF A FIRE DEPARTMENT THAT WOULD SERVE THE HENDERSONVILLE AND JONESVILLE COMMUNITIES. A BOARD OF DIRECTORS WAS ELECTED AND ERROL STYNCHCOMB WAS ELECTED CHAIRMAN, JAMES FARISH VICE-CHAIRMAN, MRS. MAYME CARTER SECRETARY-TREASURER WITH NATHAN RICHARDS, THOMAS WILLIAMS, AND CARROL CREWS AS OTHER MEMBERS. ERROL STYNCHCOMB BECAME THE FIRST CHIEF AND SERVED UNTIL 2003 WHEN HEALTH MADE HIS RETIREMENT A NECESSITY. ON DECEMBER 20, 1974, DISTRICT 1 HAD PURCHASED A USED PUMPER FROM THE ORANGEBURG FIRE DEPARTMENT AND THE FIRST CONVERTED SCHOOL BUS TANK TRUCK USED BY DISTRICT 1 WAS GIVEN TO HENDERSONVILLE AND THIS BECAME HENDERSONVILLE'S FIRST FIRE TRUCK. IN JANUARY OF 1976 A MINI-PUMPER WAS PURCHASED BY DISTRICT 1 AND THAT MADE IT POSSIBLE FOR HENDERSONVILLE TO RECEIVE ANOTHER CONVERTED SCHOOL BUS TANK

TRUCK. EQUIPMENT AND A PUMP WAS INSTALLED ON THIS TANKER AND IT SERVED WELL UNTIL DESTROYED BY FIRE. SEVERAL TANKERS WERE ACQUIRED DURING THE YEARS AND IT WAS A GREAT DAY WHEN JAMES ISLAND DONATED A PUMPER.

THE JONESVILLE AREA WAS ORIGINALLY A PART OF THE HENDERSONVILLE DISTRICT BUT DUE
TO LACK OF INTEREST IN THE JONESVILLE AREA, THE HENDERSONVILLE DISTRICT REDREW
THEIR DISTRICT LINES AND LATER THE JONESVILLE AREA (NOW DISTRICT 13) ORGANIZED.

THE FIRST FIRE STATION FOR HENDERSONVILLE WAS LOCATED ON ORCHARD ROAD ON LAND DONATED BY HASKELL LYONS.

COTTAGEVILLE-DISTRICT 9

FROM THE TIME THE FIRST RURAL FIRE DEPARTMENT WAS ORGANIZED IN COLLETON COUNTY (1968) THERE WAS A LOT OF INTEREST IN THE COTTAGEVILLE AREA WHERE ORGANIZING A FIRE DEPARTMENT WAS CONCERNED. HOWEVER, THERE NEVER WAS A CONCENTRATED EFFORT MADE FOR MANY YEARS. THE FIRST OPPORTUNITY THAT I HAD TO MEET WITH THE TOWN COUNCIL AND SOME OF THE CITIZENS OF COTAGEVILLE WAS NOVEMBER 4, 1974. MR. CHARLES GRIFFITH WAS THE MAYOR AT THAT TIME. THERE STILL SEEMED TO BE A LOT OF INTEREST BUT NOTHING MATERIALIZED UNTIL 1979.

SOMETIME IN 1975 MR. MARION BRIDGE (FORESTRY COMMISSION) CALLED ME AND ASKED IF I WOULD MEET WITH HIM TO CHECK OUT A FIRE TRUCK THAT THE FORESTRY HAD ACQUIRED. OF COURSE I JUST KNEW THIS TRUCK WAS FOR COTTAGEVILLE AS MR. BRIDGE WAS A RESIDENT OF COTTAGEVILLE AND HE KNEW I WAS DOING EVERYTHING POSSIBLE TO ESTABLISH A FIRE DEPARTMENT IN THE COTTAGEVILLE AREA. YOU CAN IMAGINE MY DISAPOINTMENT WHEN HE INFORMED ME THAT IT WAS TO BE TAKEN TO ANOTHER COUNTY.

THIS MEETING DID GIVE ME THE CHANCE TO MEET SOME FOLKS FROM THE FORESTRY IN COLUMBIA AND A FEW WEEKS LATER HERMAN L. (JACK) MOCK AND I MADE A TRIP TO THE FORESTRY HEADQUARTERS IN COLUMBIA TO INQUIRE ABOUT TWO TRUCKS (NOT FIRE TRUCKS) THAT WERE OWNED BY THE FORESTRY BUT NOT IN USE. WE WERE TOLD THAT IT

WOULD NOT BE POSSIBLE FOR US TO OBTAIN THEM AS THEY WERE PROMISED ELSEWHERE.

HOWEVER, I WENT TO MR. BRIDGE AND INFORMED HIM OF OUR CONSERVATION WITH THE

FOLKS IN COLUMBIA AND ABOUT TWO WEEKS LATER I SAW THESE TRUCKS BEING <u>DELIVERED</u>

TO MR. CHARLES GRIFFITH IN COTTAGEVILLE. EVIDENTLY MR. BRIDGE HAD PULL WITH SOMEBODY IN COLUMBIA. THE TANK FROM ONE OF THESE TRUCK WAS IN USE UNTIL JUST A FEW

YEARS AGO.

SEVERAL YEARS WENT BY AND IN 1979 MR. F. B. THOMAS AND MR. CARSON KISER CAME TO MY BUSINESS AND TOLD ME THEY HAD PURCHASED A USED FIRE TRUCK FOR COTTAGEVILLE AND WANTED MY ASSISTANCE TO HELP THEM GET ORGANIZED. OF COURSE THIS PLEASED ME VERY MUCH. THEY THEN STATED THAT THERE WAS OPPOSITION TO OPERATING UNDER THE COUNTY CHARTER BECAUSE THE BY-LAWS STATED THAT IF A DISTRICT CEASED TO EXIST THE EQUIPMENT WOULD GO TO DISTRICT 1 FOR USE ELSEWHERE IN COLLETON COUNTY. HOWEVER, DISTRICT 9 WAS ORGANIZED AND A BOARD OF DIRECTORS ELECTED. MR. JAMES COBB WAS ELECTED THE FIRST CHIEF AND HE AND I HAD A GOOD RELATIONSHIP. I CAN NOT SAY ENOUGH ABOUT MR. F. B. THOMAS AND HIS SINCERE DESIRE FOR ALL OF THE COUNTY TO HAVE ADEQUATE FIRE PROTECTION. MR. THOMAS WAS THE CHAIRMAN OF THE RURAL FIRE STUDY COMMITTEE FOR COLLETON COUNTY AND A RESIDENT OF COTTAGEVILLE. HE SPENT UNTOLD HOURS OF HIS TIME SEARCHING FOR THE BEST WAY TO FINANCE RURAL FIRE PROTECTION IN COLLETON COUNTY. THIS IS THE COMMITTEE THAT RECOMMEMDED TO THE COUNTY DELEGATION THAT THE VOLUNTEER MEMBERSHIP PLAN BE USED. FOR ALL THAT DID KNOW MR. THOMAS, KNEW HE WAS VERY "STRONG WILLED", EXPECIALLY WHERE HIS OPINIONS WERE CONCERNED. HOWEVER, AS I GOT TO KNOW MR. THOMAS I REALIZED THAT MOST OF HIS OPINIONS WERE CORRECT AS HE HAD SPENT MANY HOURS RESEARCHING A PROBLEM AND WHEN HE CAME TO STATING HIS OPINION IT WAS AN "EDUCATED" ONE.

COTTAGEVILLE AS WITH MOST OF THE OTHER DISTRICTS HAD GOOD AND BAD YEARS BUT
COTTAGEVILLE SECURED LAND BY THE PRESENT CITY HALL AND BUILT A STATION, HAD A
TELEPHONE ALERT SYSTEM INSTALLED, AND IN 1987 PURCHASED A NEW PUMPER FOR SOME

COTTAGEVILLE (DIST. 9) FIRST FIRE STATION

SIXTY-EIGHT THOUSAND DOLLARS.

AT ONE TIME COTTAGEVILLE HAD THREE STATIONS, ONE IN COTTAGEVILLE, ONE AT ROUND O, AND ONE ON HIGHWAY 61 NEXT TO THE TACKLE SHOP. THE TRUCK FROM ROUND O WAS STOLEN BUT RAN OUT OF GAS SO COTTAGEVILLE DID GET THEIR TRUCK BACK.

ORIGINALLY THE MAPLE CANE FIRE DEPARTMENT (DISTRICT 11) WAS A PART OF COTTAGEVILLE BUT IT SEEMS THAT THE LADIES FROM MAPLE CANE HAD RAISED THE FUNDS TO PURCHASE A FIRE TRUCK FOR THE MAPLE CANE AREA AND IN 1984 THE FIRE TRUCK IN COTTAGEVILLE HAD PROBLEMS AND <u>SOMEONE</u> TOOK THE TRUCK FROM MAPLE CANE FOR USE IN COTTAGEVILLE.

THAT DID NOT GO OVER TOO WELL WITH THE FOLKS IN THE MAPLE CANE AREA AND DISTRICT 11 (MAPLE CANE) WAS ORGANIZED SHORTLY THEREAFTER.

ISLANDTON DISTRICT 10

THE ISLANDTON FIRE DEPARTMENT WAS THE LAST TO ORGANIZE TO MEET THE ORIGINAL REQUIREMENTS OF THE INSURANCE SERVICE OFFICES THAT REQUIRED TEN FIRE DEPARTMENTS BE ORGANIZED AND EQUIPPED TO ALLOW ALL OF COLLETON COUNTY TO RECEIVE A REDUCTION IN THE COST OF FIRE INSURANCE. THIS RATING WAS TO BE CLASS 9.

THIS DEPARTMENT WAS FIRST ORGANIZED IN 1981 AFTER A DISASTEROUS FIRE ON SINEATH ROAD AT THE HOME OF RUDOLPH MILLS MADE THE NEED FOR FIRE PROTECTION A STRONG REALITY IN THE ISLANDTON AREA.

ISLANDTON'S FIRST FIRE TRUCK WAS PURCHASED FROM SUMTER IN SEPTEMBER OF 1981 WITH A LOAN OF \$8,290.96 FROM THE HAMPTON COUNTY BANK. THIS UNIT WAS PAINTED BY WENDELL BISHOP AND SERVED THIS COMMUNITY WELL. IN OCTOBER OF 1984, RHODES OIL AND STONE OIL COMPANY DONATED USED FUEL OIL TRUCKS TO BE USED BY THE FIRE DEPARTMENT.

ONLY RECENTLY WERE THESE UNITS REPLACED WITH MORE MODERN EQUIPMENT.

THE FIRST FIRE STATION FOR ISLANDTON WAS LOCATED AT 547 ASHTON ROAD ON LAND

DONATED TO THE RICE PATCH CHRISTIAN CHURCH BY WILLIE CECIL GODLEY AND DOROTHY

GODLEY ROBERTS. THE RICE PATCH CHRISTIAN CHURCH THEN LEASED THIS LAND TO THE ISLANDTON FIRE DEPARTMENT FOR NINETY-NINE YEARS. A LOAN FROM BERNICE C. SINEATH IN THE AMOUNT OF \$5,000.00 MADE IT POSSIBLE TO ERECT THE FIRST FIRE STATION. THIS IS NOW STATION 15 WITH STATION 10 BEING LOCATED AT 1985 ADNAH CHURCH ROAD, THANKS TO THE GENEROSITY OF LARRY AND VERNON RAHN.

THE FIRST BOARD OF DIRECTORS WERE JOHN CHARLES SINEATH, CHAIRMAN, WENDELL BISHOP, VICE CHAIRMAN, W. T. STANFIELD, SECRETARY, AND TRAVIS GODLEY, TREASURER. THE OTHER MEMBERS WERE E. KENNETH GODLEY, WILLIS KINARD, LARRY RAHN, NATHAN STEPHENS, AND ELDRIDGE WILLIAMS. W. TED STANFIELD, SR. SERVED AS THE FIRST CHIEF FOLLOWED BY TONY DICKS, EVERETTE POLK AND AS OF THIS DATE, MATT WILLIAMS.

EDISTO BEACH FIRE DEPARTMENT

FOR MANY YEARS THE TOWN OF EDISTO BEACH HAD BEEN INTERESTED IN FIRE PROTECTION AS EVIDENCED BY THEIR SECURING A PUMPER FROM PARRIS ISLAND THROUGH THE OFFICE OF CIVIL DEFENSE. THIS WAS A 1953 WARD LAFRANCE PUMPER WITH MAJOR PROBLEMS. SOMETIME IN 1976 (EDISTO BEACH HAD ANNEXED INTO COLLETON COUNTY IN 1975) I WAS ASKED TO COME TO EDISTO BEACH IN AN EFFORT TO ASSIST THEM IN PUTTING THIS PUMPER IN SERVICE. THIS PUMPER DID NOT HAVE ANY WAY TO UTILIZE THE HYDRANTS THAT WERE IN PLACE AT THAT TIME. THIS WAS MY FIRST PRIORITY AND WE FASHIONED A VALVE THAT DID WORK GREAT. HOWEVER, WE THEN FOUND A HUGE OIL LEAK FROM THE ENGINE OIL PAN THAT MADE IT IMPOSSIBLE TO OPERATE THE PUMPER. WITHIN THE NEXT SEVERAL MONTHS IT BECAME APPARENT THAT THIS PUMPER WAS BEYOND ECONOMICAL REPAIR. I FELT THAT THIS WOULD END THEIR EFFORTS WHERE FIRE PROTECTION WAS CONCERNED BUT I WAS VERY PLEASANTLY SURPRISED.

EDISTO BEACH WAS ORIGINALY CONSIDERED AS DISTRICT 11 BUT THE TOWN COUNCIL SOON DECIDED THAT IT WAS BEST FOR THE TOWN TO OWN AND OPERATE THEIR FIRE DEPARTMENT. IT WAS VERY ENCOURAGING WHEN I RECEIVED A CALL REQUESTING THAT I RECOMMEND TO TOWN COUNCIL THE PUMPER AND EQUIPMENT THAT WOULD GIVE THEM A GOOD START ON

PROVIDING FIRE PROTECTION AND RECEIVING A REDUCTION IN FIRE INSURANCE PREMIUMS
AS THEY WERE CONSIDERING INSTALLING MORE FIRE HYDRANTS IN THE VERY NEAR FUTURE.

I IMMEDIATELY CONTACTED THE INSURANCE SERVICES OFFICE AND RECEIVED A LISTING OF WHAT WAS NEEDED FOR THEM TO QUALIFY FOR A REDUCED FIRE INSURANCE RATING. I WAS THEN REQUESTED BY TOWN COUNCIL TO OBTAIN THE APPROXIMATE COST.

I HAD ESTABLISHED A VERY GOOD RELATIONSHIP WITH A REPRESENTATIVE THAT SOLD FIRE EQUIPMENT (HE WAS EXTREMELY HONEST) AND I ASKED HIM TO STOP BY MY BUSINESS AND CONTACT ME CONCERNING EDISTO BEACH. WITHIN THE NEXT FEW WEEKS HE COMPLETED HIS PROPOSAL AND AGREED TO MEET WITH TOWN COUNCIL AT EDISTO BEACH.

THE NEXT DAY (AFTER MEETING WITH COUNCIL) HE CALLED ME AND STATED THAT THIS
GROUP WAS DEFINITELY READY TO PROVIDE FIRE PROTECTION. HE SAID THAT AFTER HE
PRESENTED HIS PROPOSAL THEY ASKED HIM TO WAIT OUTSIDE IN CASE THEY NEEDED MORE
INFORMATION AND IN ABOUT THIRTY MINUTES THEY ASKED HIM TO COME BACK INSIDE AND
LET THEM KNOW WHEN THE PUMPER AND EQUIPMENT WOULD BE DELIVERED. HE STATED
THAT THIS WAS ONE SALE HE WAS PROUD OF (PROBABLY ONE OF HIS EASIEST) BECAUSE
EVERYONE ON TOWN COUNCIL HAD MADE PROVIDING FIRE PROTECTION A TOP PRIORITY.

THIS PUMER WAS DELIVERED IN FEBRUARY OF 1977 AND WHEN THE REPRESENTATIVE MAKING
THE DELIVERY STOPPED BY MY BUSINESS ON THE WAY TO THE BEACH IT GAVE ME GREAT
PLEASURE TO BE ABLE TO INSPECT THIS PUMPER AND TAKE THESE PICTURES SHOWN HERE.

MR. MARION WHALEY WAS THE MAYOR WHEN THIS PUMPER WAS DELIVERED AND MR. HARVEY KIZER (A TOWN COUNCILMAN) WAS TO BE THE FIRE CHIEF. I BECAME FRIENDS WITH BOTH OF THESE MEN AND DID EVERYTHING I COULD TO HELP WHICH REALLY WASN'T MUCH BECAUSE THEY REALLY HAD THEIR ACT TOGETHER

THANKS TO MR. JOE HICKMAN, THE CIVIL DEFENSE DIRECTOR, WE WERE ABLE TO SECURE A LARGE TANKER FOR EDISTO BEACH. THIS TANKER WAS LATER USED BY THE HENDERSON-

VILLE DISTRICT FOR MANY YEARS. THE 1953 WARD LAFRANCE THAT HAD BEEN SECURED BY CIVIL DEFENSE FROM PARRIS ISLAND WAS RETURNED TO WALTERBORO AND LATER GIVEN TO LODGE. LODGE CAME TO THE SAME CONCLUSION AS EDISTO BEACH (THAT IT WAS BEYOND ECONOMICAL REPAIR) AND THE LAST TIME I SAW IT WAS IN A FIELD ABOUT TWO MILES NORTH OF LODGE.

OF COURSE MANY CHANGES HAVE BEEN MADE AT EDISTO BEACH SINCE 1977 BUT I WILL ALWAYS APPRECIATE THE FACT THAT I HAD A PART IN HELPING ORGANIZE THE FIRST "REAL" FIRE DEPARTMENT AT EDISTO BEACH.
