State Fire Marshal's Guide to the DSS Licensing Process



Child Care Center

- Child care centers are facilities keeping
 - 6 or more children for less than 24 hours per day
- All facilities licensed by DSS as a child care center must comply with all fire codes
 - Facilities sponsored by religious entities
 - Head Start programs
 - Kindergarten in public schools
 - Public or private child care centers



Once You Receive the DSS Child Care Center Licensing Packet

- Click on the statement that best describes your center:
 - We are building a new building
 - We are a new owner of an existing center
 - We are adding children under 30 months of age to our existing center
 - We are increasing the number of children on our license
 - We are moving into an existing building
 - All others situations



Your facility will be treated as a new building or construction

- Questions you need to answer for your Architect:
 - How many children will you keep?
 - Will you keep children under 30 months of age?
 - What are your hours of operation?
 - Will you have equipment for cooking or warming food?
- State law requires a licensed architect prepare plans for your facility
 - Select an architect with child care center experience
 - You may verify an architect's license on "Licensee Lookup"
 - https://verify.llronline.com/LicLookup/LookupMain.aspx
 - Select "Architects" from the drop down menu
 - Once plans are prepared:
 - The State Fire Marshal must receive one (1) set of sealed building plans
 - Submitted plans will be kept on file as a matter of public record for three (3) years



New Construction (continued)

- Your architect will determine if a fire alarm system is required:
 - You will need to hire a licensed fire alarm contractor
 - Select a contractor with child care center experience
 - You may verify the contractor's license on "Licensee Lookup"
 - https://verify.llronline.com/LicLookup/LookupMain.aspx
 - Burglar/Fire Alarm And Fire Sprinklers
 - Once fire alarm shop drawings are prepared:
 - The State Fire Marshal must receive one (1) set of shop drawings
 - Submitted plans will be kept on file as a matter of public record for three (3) years



New Construction (continued)

- A commercial hood and fire suppression system is required for all daycare centers:
 - You will need to hire a licensed fire equipment dealer
 - Look in the phone book to find a list of local contractors
 - Licenses may be verified by calling the State Fire Marshal's Office (803) 896-9802
 - Select a contractor with child care center experience
 - Have your contractor coordinate with the Deputy State Fire Marshal for a hood system acceptance test



State Fire Marshal Plan Review Process

- Plans are received
 - Logged into computer tracking system
 - Assigned a project number
 - Assigned an engineering staff member to review the plans
 - Plans are reviewed in the order received
 - Initial reviews may take as long as 30 days
 - Plans not approved on first submission
 - The architect, Deputy State Fire Marshal, and DSS receive copies of the review letter

When Plans Are Not Approved

- The architect/contractor must revise the plans based on the review letter
- Revised plans must be reviewed again
 - Plans are reviewed based on date received
 - Stay on top of your architect/contractor so they resubmit plans promptly
 - Be sure resubmitted plans have a response letter to State Fire Marshal's staff. Please include the SFM project number (all projects are issued a project number upon first receipt), name of facility, and street address



Construction/Renovations

- Remember to apply for local permits!
- Start building or remodeling
 - If you build before having approved plans, you build at your own risk!
- Continue with DSS on your licensing packet
- Near completion
 - Contact DSS to arrange for an inspection from a local Fire Inspector or Deputy State Fire Marshal



Before the Deputy Arrives

- Have copies of all test certificates and approved drawings
 - Fire alarm & sprinkler system (if applicable)
 - Interior furnishing (carpeting, draperies, etc)
 - Hood System Inspection report
- For new or modified fire alarm systems
 - Arrange for the fire alarm contractor to be present the day of your inspection
- Have keys to open all spaces in the facility



Inspection Day

- The Deputy will:
 - Inspect your facility
 - Review all test reports and documents
 - Review findings
 - Print and leave you a copy of the report
- If an re-inspection is needed
 - Contact the original inspector once corrections are completed
- Reports from the SFM are sent to DSS for licensing, reports from the local inspectors are the responsibility of the daycare owner to provide to DSS

Answer These Questions About Your Existing Building

- Click on the statement best describes your facility:
 - My building was a child care center before and:
 - My building was closed for 1 year or more
 - My building was closed for less than 1 year
 - My building was something besides a child care center

Your Must Document Fire Code Compliance for Your Facility

- Questions you need to answer for your architect:
 - How many children will you keep?
 - Will you keep children under 30 months of age?
 - What are you hours of operation?
 - Will you have equipment for cooking or warming food?
- State law requires a licensed architect prepare plans for the renovations your facility
 - Select an architect with child care center experience (ask for references!)
 - You may verify an architect's license on "Licensee Lookup"

 - Select "Architects" from the drop down menu



Fire Code Compliance Existing Facilities

- Tell your architect you will need:
 - "As-Built plans" (showing code compliance or needed renovations)
 - A code analysis of the facility for compliance with the currently adopted codes
 - The State Fire Marshal must receive one (1) set of sealed building plans (these plans will be kept on file as a matter of public record for three (3) years and will not be returned)
- Your Architect will determine if fire alarm system meets current codes or needs modification:
 - If your system needs modification, you will need to hire a licensed fire alarm contractor
 - Select a contractor with child care center experience (ask for references!)
 - You may verify the contractor's license on "Licensee Lookup"
 - https://verify.llronline.com/LicLookup/LookupMain.aspx
 - Burglar/Fire Alarm And Fire Sprinklers
 - Once fire alarm shop drawings are prepared, submit one (1) set of shop drawings to the State Fire Marshal's Office for review



Fire Code Compliance Existing Facilities (cont)

- Your architect/Deputy State Fire Marshal will determine if a commercial hood is required, meets current codes, or needs modifications:
 - If your system needs modification, you will need to hire a licensed fire equipment dealer
 - Licenses may be verified by calling the State Fire Marshal's Office (803) 896-9802
 - Select a contractor with child care center experience
 - Have your contractor coordinate with the Deputy State
 Fire Marshal for a hood system acceptance test



Fire Code Compliance Existing Facilities (cont)

- When your architect completes the drawings:
 - The State Fire Marshal must receive one (1) set of sealed plans. These plans will <u>not</u> be returned. These plans will be kept on file as a matter of public record for three (3) years.
